TACTS have emerged on why uncompleted threestorey located at Oguta Road, Onitsha, in Anambra State collapsed Wednesday evening with about 30 persons, including labourers escaping death. unconfirmed

EFCC has filed fresh proofs of evidence against former governor of Taraba state, Rev. Jolly Nyame over his ongoing trial in N180 million scam preferred against him by the anti-graft agency. The additional evidence was filed at the High Court of the Federal Capital Territory (FCT) Abuja Justice Adebukola before Banioko.

The (EFCC) also filed before the court an additional list of witnesses who have information volunteered that would be useful in the prosecution of the case. Some of the witnesses include bank staff and serving government officials. *Among the additional proofs

of evidence brought forward by the EFCC against Nyame are banks' account opening packages by some aides of Nyame: certified true copies of account opening packages of some of the aides of the former governor, certified true copies of statements of accounts and certified true copies of 18 different cheque books.
