More troubles for Rev King

Stock market value rises by #56bn

MARKET capitalisation of the Nigerian Stock Exchange (NSE) increased yesterday by N56 billion or 1.74 per cent, from N3.211 trillion to N3.267 trillion, while the all-share index closed lower at 28,233.48 points, as against 28,233.55 points it closed the previous day, representing a growth 1.74 per cent.

Meanwhile, the stock market turnover also rose by over 53 per cent to a total of 189,117,452 shares valued at N2.779 billion in 7,591 deals, in contrast to 123,145,155 shares worth N2.152 billion traded in 7,243 deals recorded the previous day.

Analysis of equity transactions revealed that the banking subsector recorded the highest volume of traded shares. It traded in 4,470 deals, a total of 145.133 million ordinary shares valued at N1.850 billion.

In the banking subsector, United Bank for Africa Plc emerged as the most actively

MORE troubles await the General Overseer of the Christian Praying Assembly (CPA) Ajao Estate, Lagos, Rev. Emeka Ezeugo King as the police are set to file murder charges against

Dr King, who was granted bail in the sum of N2 million with two-sureties of the same sum by Ebute-Metta Magistrate's Court, Lagos yesterday had his case worsened following the death of one of his victims who was receiving treatment in a private hospital in Ajao Estate.

Prosecution counsel Mr Ochugbo Ogbeh told the court that the victim whose name he did not disclose passed on few minutes before commencement of court proceedings.

Corroborating Ogbeh's account, Deputy Commissioner of Police (DCP) in charge of State Criminal Investigation

Department (SCID), Panti, Yaba, Lagos, Mr Olayinka Balogun said: "That is what I have heard".

Speaking with Daily Champion Mr Balogun said: "If it is confirmed, we are going to substitute our charge with murder charge. We have called for the medical report".

Rev. King was arrested July 23 for allegedly setting fire on some of his church members after accusing them of fornication. The victims were hospitalised having suffered severe burns.

The cleric had been in detention at Panti.

But Rev. King was yesterday granted bail in the sum of N2 million with two sureties who must reside and have landed property within the Lagos metropolis.

The pastor with two others—Donatus Chiazor and Kelechi Chikere—Queen was arraigned before a Magistrate's Court at Ebute-Metta, Lagos, "presided by
