Communal clash victims for mass burial

PEACE and Conflict Resolution Committee in Bayelsa state is to take over the burial of victims of a recent inter communal clash in Igbomoturu, in Southern liaw local government area.

the committee. assured that there would be no subsequent military invasion in the state.

At least 70 persons allegedly lost their lives, while the entire community was deserted during the period.

Disclosing this to newsmen in Yenagoa at a media briefing, Monday, the state chairman of the committee, Chief James Jephtar said for normalcy to return to the warring community, the committee had to apply Alternative Distributive Resolution method, adding that the approach yielded positive results as people have started returning to the community.

He also disclosed that as part of measure to restore peace in the community, the Committee has agreed to bury the corpse of those allegedly killed during the clash.

On the purported plan of military invasion, the chairman said there was an initial plan to carry out the onslaught due to series of unchecked activities of the militant youths which made the country to loose billions of

Jephtar stated government can no longer fold its arms and allowing criminal activities to continue unabated in the Country, noting that oil companies are gradually folding up their exploration and exploitation activities in the region.

He said, "The activities of the militant youths necessitated the setting up of this committee both at the National and States levels and since inauguration we have being visiting various militant camps in the Creeks and it has been a huge success.

Before now, he said uniform men were not allowed into Southern Ijaw territory, but during our visit there uniformed men were allowed as we have as part of our team. Assistant Commissioner of Police, senior office from the State Security Service and others.

"Yes, the JTF was given information about purported plan of some of the youths to attack the EA field of the Shell Petroleum Development Company in the area and to prevent the attack, the JTF men attacked the shrine but nobody was killed. The place was even deserted before the soldiers got there."

Following the development, he said he had registered his displeasure and even threatened to resign his appointment, before he was assured that such incident would not reoccur.


Joshua and Africa formally welcomed the peace and reconciliation committee, before the close door meeting between the federal government delegation and militants.
