THE tussle for the stool of Obong of Calabar, Cross River State, turned bloody yesterday with the murder of one person by some armed thugs, who allegedly invaded Cobham town, the home of the monarch, Edidem Bassey Ekpo Bassey II. Sources said the attack, which

took place at about 4 am, was carried out by thugs hired by a faction of Etuborns (kingmakers). It was further gathered that the whereabouts of about nine members of the Cobham Town were unknown aside from the

one confirmed dead. Sources alleged that the nine persons may have been killed or kidnapped by the invaders, who also carried away the corpse of the deceased, whose identity could not be ascertained as at

The attack took place despite the recent warning by the State Governor Livel Imoke that government would not tolerate any form of violence again from those seeking to occupy the Efik throne.

The latest invasion of Cobham town was the fifth attempt to forcefully cap Etubom Otu at the Efe Asabo (kingship shrine) and the fourth time the community was being invaded since April 21. When our Correspondent visited Cobham town at about

7am yesterday, the entire place was tensed up and the residents were gripped with fear. The people were seen in clusters discussing in low tones. A few persons, who spoke to Saturday Champion on condition

of anonymity, alleged that the

thuas invaded the community from No. 7 Efanga Ansa Street, where they have been using as their base since the demise of the former Obong of Calabar, Edidem

(Prof) Nta Elijah Henshaw VI. They entered the community in the early hours of the morning and made straight for the kingship

shrine where they met some of the quards who attempted to stop them from gaining entrance to stop the sacrilege of a second capping of another person as Obong.

Sources said in the ensuing melee, one of the shrine guards was killed by the thugs, who were armed with dangerous weapons and thereafter carried the corpse of the deceased away when it became obvious that the commotion at the shrine had alerted other members of the community, who immediately mobilized to ward off the
