
Crisis: One killed, 100 houses razed in Ebonyi

THE seven-month-old tussle for the ownership of NICON Insurance Plc and Nigeria Reinsurance Corporation ended weekend with the Federal Government decision to return

the two companies to the core investor, Barrister Jimoh Ibrahim.
