4 feared dead as another building collapses

AT least four persons were feared killed yesterday when an uncompleted three-storey building collapsed in Ikorodu, Lagos State. Five others, including a couple and their five-year-old

baby whose identities could not be ascertained, were rescued from the wreckage

Daily Champion recalls that another building had collapsed Monday at Igboelerin in the Iba area of Lagos State, killing at least two persons.

However, in the latest incident,

a body of one of the victims as well as a man who reportedly called for help via his telephone were among those still trapped as at press time.

The survivors including a couple and their child, our correspondents gathered,

are receiving treatment at undisclosed hospital at lkorodu. The incident occurred at about 1.45 yesterday.

When our correspondents visited the 21 Nosiru Alunwon Street, Eyita Estate, Ikorodu, scene

"According to him, the bread winner, Emeka runs a fashion shop along the road with two trade servants and two brothers. Now he has lost one brother and servant while himself, wife and daughter are in intensive care unit."

Ikenna revealed that Emeka and family are the first set of tenants to pack into the building which has two-room self contained on each floor of the back of the main three storey building.

However, on the executive orders of the Ikorodu local government chairman, the three storey building in front of the collapsed house was yesterday marked for demolition based on the fact that the about four-year structure has already developed observable cracks from the last floor. Collapsed building

Ikenna revealed that Emeka and family were the first set of tenants to move into the building which has a two-room, self contained apartment on on each floor of the back of the main threestorey building.

However, on the executive orders of the Ikorodu Local Government chairman, the threestorey building in front of the collapsed house was yesterday marked for demolition based on the fact that the nearly four-year structure has already developed the cracks from observable last floor. The demolition order immediately prompted the already-jittery residents to start moving their property away from the compound as bulldozers are expected to hit the site today.

Contacted, experts from the Lagos State Ministry of Physical Planning and Urban Development said the main, building would be demolished today because it has substantiated evidence of

collapse in not-too-distant time. He argued that the collapsed building "was not only hurried but was developed with substandard materials, poor cement contacts and very unacceptable quality of reinforcement."

Collapse of buildings under construction in the state has been on the increase

Only recently, a new structure being put up by a new-generation bank caved in Ogudu in the Ojota axis, instantly killing five.

It would be recalled that the Lagos State government had earlier in the month directed the immediate evacuation of residents of about eight blocks of flats within the Sogunzo Low Cost Housing Estate in the Ogba

The Deputy Governor, Mrs. Sarah Sosan, while handing down the order, warned residents to leave the building which had displayed signs of collapse, cracks and to always report same to the government in the overall public interest.

An environmental engineer, Dr. Daniel Agu, observed in a telephone interview that the rainy season always saturated the state's solid earth with weak foundation and defects.

Only this March, Lagos State has scaled the highest cases of building collapse in the last five years.
