NAFDAC made the arrest even as it discovered that three more children had did on Wednesday in Kaduna as a result of the taking the syrup.

The Tranxell boss whose chemical shop was also sealed has been handed over to the police for further interrogation.

criticisms were not justified, given the problems that INEC was faced with, prior to the elections.

He insisted that the 2007 general election was successful considering the prevailing condition under which the Independent National Electoral Commission (INEC) conducted the poll.

"It is easy for people to condemn the electoral body at the centre but look at what ishappening in the states where they have to conduct only Local Government Elections but here is an INEC that had to conduct elections in the 36 states of the federation and Abuia and we did not see the level of destructions that are being recorded in the states," he said.

The VP said most of the criticisms on the person of Iwu and his INEC were not justified going by the enormity of troubles the commission had to contend with while conducting

Mosque, he said it was evident that the victims died of gun shot wounds which he was very sure was from the police who were drafted to keep peace.

Also supervising the burial ceremony, Lt. Col. Mohammed Sa'id, who represented the Chief of Army Staff, said the army came to provide its little contributions by way of providing burial materials for the dead.

Most Christians failed to worship in their respective churches for fear of attacks, as the chaotic situation worsened yesterday, with government adding another two hours to the earlier 12 hours curfew in parts of the state.

Also, church activities, including marriages and social gatherings had to be suspended indefinitely as a result of the crisis.

The Christian Association of Nigeria, CAN, Plateau State chapter alleged that the crisis was religious and not political as some people are indicating. The government equally stressed that mercenaries were brought into the state from nearby states by unknown persons.

ensure that instigators of this mass loss of Nigerian lives are censured.

"It is with great shock that I have learnt of yet another tragic turn into violent in response to perception of what may or not may be appropriate outcomes from political matters with this new wave of arson and murder in Plateau State"

"Whatever at all may be the reasons, the taking of human lives is unacceptable and condemnable just as is the deliberate destruction of property."

"As we have said again and again, our nation cannot make progress until the dignity of the human person and the inestimable value of every soul is placed above any material consideration or power consideration."

"Part of the crisis of development of our country is this failure of culture in which the dignity of man is inalienable and uncontestable."

"I am calling on all authorities at all levels to visit with a maximum show of disagreement for such conduct, all who may be implicated in any shape or form in plotting and executing the loss of the lives of Nigerians."

Also Afenifere Renewal Group (ARG) condemned the violence, saying it was sparked off by the usual Peoples Democratic Party, (PDP) game of manipulating the electoral process with impunity, which has characterized their mantra of 'do-or-die' politics.

"The Jos response is just a tip of the iceberg of what we have always warned could happen when you push a people to the wall. It takes just a spark to ignite an unquenchable fire of angst bottled-up over a period of time. And, in a society where there are other welled-up social tensions, a conflagration is just a heartbeat away.

"It is unfortunate that what we have heard from the presidency, which, itself is also hanging on a dubious mandate is a tepid response to the violence in Jos without the moral authority to address the electoral manipulation that has given rise to this wanton loss of lives and property.

"It an indictment of the Nigerian political while leadership ' that, neighbouring Ghana matching on peacefully towards its December 2008, presidential elections, Nigeria is being exposed as a headache to the world over council polls.

"ARG sues for calm in Plateau State as the wanton destruction of lives and property affects mainly the ordinary people who are victims of a manipulative, indecent and avaricious political class."
