Eye witnesses believed that he killed her aunt after reading the book of Moses.

Daily Champion leant the police in Anambra State have arrested the young

man who allegedly cut off her aunt's head and buried it differently from her body near an uncompleted building.

The police said Chidi had 'confessed to the crime. He is being held with her parents, sisters and brothers. He was said to be reading mystical books.

Anambra State Police Public Relations Officer, Emeka Chukwuemeka said although the boy confessed to the crime, the police would still carry out further investigations to establish the motive of the crime.

Chukwuemeka said, "This is heinous. This is a heinous crime as far as we are concerned. The suspect has been arrested. We are working on the lead that he could not have committed the crime alone. We will eventually arrest those that must have carried out the act

with him,".

Family members said until the disappearance of Magi as she was called, there was no love lost between the families and that the suspect's mother had been married to the brother of the deceased one child for the deceased's brother left him and went outside to have the suspect, his sister and brother.

Stories had it that she returned to her husband's house later on but never made up with her sister in-law (the deceased).

House sacks ANSIEC boss for alleged fraud

THE hope to conduct elections the into local government areas in Anambra state this December 2011 has been dashed as the Anambra state House of Assembly vesterday sacked Chairman of the Anambra Independent state Electoral Commission (ANSIEC), Prof. Titus Eze over financial impropriety.

Daily Champion leant the Secretary to the state Government, Chief Paul Odenigbo wrote the House intimating them on the fraudulent practices observed by the state Auditors in the commission under Prof Eze. This the state government did because the Governor could not have sacked the ANSIEC Chairman without two /third majority of the members of the House.

So during the yesterday sitting presided over by the Speaker, Rt Hon Clair Nwebili 23 members voted in favour of Prof Titus Eze's sack out of the 24 that attended the sitting.

Prof. Eze was accused of embezzling N100 Million meant for preparation of local government election as he only spent N6 million without due process. He was also alleged to have embezzled another N6 Million meant for voters register in collaboration.

with INEC as INEC said the ANSIEC did not contribute a dime to them during the exercise.

Reacting , Prof Eze dismissed the allegation saying it was the handiwork of those who don't want free and fair election.

Before pow \ the commission, was busy telling all who care to listen to them that elections would be conducted immediately after the general elections and later December this vear but with this sack of ANSIEC Chairman Prof Eze who was said to be above board when he was appointed, the chances of an election is limited.
