Gunmen kill court registrar in Borno

Gunmen suspected to be members of the Yusufiyva sect popularly known as Boko Haram on Sunday night in Maiduguri shot dead a registrar at the Borno state High Court.

The court registrar Mallam Baba Loskurima according to witnesses was shot dead by the gunmen in front of his house in Tandari area of Maiduguri around 7pm.

Our correspondent learnt that the gunmen after killing him took away his car and undisclosed amount of money before they fled the scene.

The deceased it was gathered was a principal registrar and protocol officer to the state chief judge, Justice Kashim Zanna.

Confirming the incident, Police Public Relations Officer (PPRO), Borno state command, the victim was shot at his residence on Sunday night.
