Boko Haram wants to carve an Islamic state out of Nigeria, a country of 170 million people split roughly evenly between Christians and Muslims. The insurgency is seen as the top security threat to Africa's leading oil and gas producer.

Nigeria plans to deploy around 1,200 troops as part of a West African intervention force to combat Islamist militants occupying the north of Mali, and officials fear Nigeria's involvement could further inflame its own insurgency.

Meanwhile, President Goodluck Jonathan yesterday in Geneva said tackling global jihadists was in Nigeria's

interest because of the links between its Islamists and those in the desert states to the north, like Mali. An Islamist group known as which has been Ansaru, blamed for abducting and killing Westerners, claimed responsibility for an attack on Nigerian troops heading to Mali on Sunday that killed two

Boko Haram's longbearded members practice a strict Wahhabist version of Islam that regards anyone who disagrees with it as infidels. They frequently target bars and other forms of entertainment.

Militants have killed several hundred people in the past three years in a campaign to impose sharia, Islamic law, on Nigeria. Their targets include the security forces and churches, although they have killed more Muslims than Christians.

Meanwhile, the Kano State Government yesterday banned the activities of commercial motorcyclists in the state from January 24.

Deputy Governor of the state, Dr Abdullahi Ganduje, who announced the ban in a broadcast in Kano, said the measure became imperative considering the current situation in the state.

The ban is coming in the wake of last Saturday's attack on the convoy of the Emir of Kano, Alhaji Ado Bayero.

Ganduje said: "The action became imperative so as to ensure that all commercial activities of motorcyclists in the state were registered in their local government as part of government measures to ensure security in the state".

He said the ban would take effect on all commercial activities of the motorcyclists from January 24, adding that the attack on emir's convoy shook the city of Kano.

Reacting to the ban, National President Amalgamated Commercial Owners/Riders Association of Nigeria, Mallam Muhammad Hassan, however, described development `unpleasant and highly devastating".

Hassan said no fewer than 1.5 million people would be rendered jobless by the government's pronouncement.

He then called on the government to come up with a new measure that could create job opportunities for the people that were rendered jobless by the new policy.

all legal provisions available to Parliament to compel appearance of the ministers, including issuing a warrant of arrest, if need be.

He said: "We are absolutely not happy with developments today. You may have observed that all the critical persons we need to proceed are not here. Starting from the Chairman of SURE-P, Christopher Kolade that we excused since he obtained an excuse not to be in this proceeding, all the honourable ministers invited are not here. The CBN Governor is not here and the Committee interprets this to be an intentional disrespect for Parliament and its proceedings. This is totally unacceptable

"Any attempt to ridicule the National Assembly of Nigeria will be resisted. We have adequate laws to ensure that we hold our people accountable for their actions and whatever office they occupy. They (ministers) hold such offices in trust for the Nigerian people. If you don't want to be involved in public service, please stay in your house.

"This intentional of disrespect will not be condoned. I see this as

deliberate contempt. I want to appeal that in the light of this development, we cannot broceed, but let me warn that we will not tolerate it again. As for ministers, we expect certain level of ethical conduct. I can't remember anyone calling me or my clerk asking to be excused.

"With large scale in the fraud uncovered now discredited federal government's petroleum subsidy regime and the programme failing to achieve nationwide uniform fuel pricing in line with the official N97 per litre subsidized petrol rate, questions have been raised on the sustainability and 3 need for the programme.

"PEF is a scheduled parastatal of the Federal Ministry of Petroleum Resources established mainly to administer uniform prices petroleum products throughout the country, a function not seen or felt by Nigerian consumers except through the lens of dubious payment of bridging claims to oil marketers by the fund administrators".

Citing breach of provisions of the Procurement Act, the House of Representatives in November, gave their backing to a motion seeking the suspension of work on 17 ecological projects across the country worth N3.7 billion.
