# 52-Y-OLD FARMER STABS SON TO DEATH.REMANDED IN PRISON

A **52-year old farmer**, Joseph Akaachigir, was yesterday arraigned before a Makurdi Chief Magistrate Court for allegedly stabbing his 20-year-**old son**, Orngu, to **death**.

Prosecuting Police Officer, Inspector Sunday Ameh, disclosed that the case was transferred from Divisional Headquarters, Ukum to the State CID. Ameh said the accused person of Tse-Akaachigh village in Ukum Local Government Area of **Benue** State had February 17, 2013 unlawfully and without provocation, stabbed his **son** with a knife on his left leg. He said the **deceased wanted to mediate in a fight** between his mother and father and the knife that was meant to stab the woman by the accused person strayed to him. The prosecutor said the deceased was immediately rushed to City Clinic, Kyado where he later died. According to the prosecutor, the accused person was arrested during police investigation and he confessed to have killed his **son** when he meant to stab his wife. When the case came up for mention, the accused person did not take plea because the court

lacked jurisdiction over the matter. However, prosecutor informed the court that investigation into the matter was still in progress and asked for another date for further mention. The Chief Magistrate, Mrs. Theresa Wergba, ordered that the accused person be remanded in prison custody and adjourned the matter to April 18, 2013 for further mention.
