Nine die after Jigawa PDP rally

Tine members of the People's Democratic Party (PDP) died on Friday while eight others are in critical condition at the Dutse General Hospital after their vehicles collided along the Dutse-Shuwarin road.

Police quiz governorship aspirant

he police in Plateau state have questioned a People's Democratic Party (PDP) gubernatorial aspirant (names withheld) and two others over the murder of a governorship aspirant in the state, Chief Jesse Aruku, Daily Trust has learnt.

Investigations by our correspondent revealed yesterday that the gubernatorial aspirant who hails from the same local government with the late Aruku, was at the police headquarters in Jos where he was being interrogated by the police in connection with the murder.

The police public relations officer in Jos, Mr. Dominic Iornumbe, when contacted said he was not in a position to comment on the matter, explaining that the state's Police Commissioner, Mr. Richard Chime, will address the press on the progress of investigations today.

But our correspondent learnt that one of the men detained by the police has made useful statements, including claims that he can identify the killers of the late Aruku.

The suspect was said to

have told the police that he had seen the alleged killers trailing Aruku while he was leaving the hotel the night he was murdered.

Efforts to reach the gubernatorial aspirant and seek his reaction failed as he refused to pick his phone cells when our correspondent tried to reach him.

The late Chief Aruku's corpse was discovered last Sunday after a sudden disappearance. He was said to have spent sometime at an undisclosed hotel from where his assailants are believed to have trailed and later abducted him.
