Riots break out in Lagos

iots broke out yesterday in Lagos when commercial vehicle operatives took to the streets protesting at

the alleged shooting of one of their members by policemen and Traffic management officials. Members of the National

Union of Roads Transport Workers [NURTW] and the Road Transport Employers Ass-

ociation on Nigeria [RTEAN], clashed with the Police and the state Traffic Maintenance Authority, [LASTMA] officials at the Ojota-Maryland axis of

Lagos state.

Police responded with teargas. The riots also paralysed activities at Anthony area and Oshodi for hours, forcing workers to trek long distances to their

office yesterday morning. Our correspondent gathered that the fracas which started as early as 7 am, spread from Ojota bus stop to Maryland, was a planned confrontation by the commercial drivers to put a stop to the alleged constant extortion

policeman. Confirming the crisis that brought " area to standstill, the Chief Executive Officer of LASTMA, Mr. Young Arebamen said no mater what the commercial hus drivers do. state capital while receiving an award from "Zone E" of the Nigerian Union of Journalists (NUJ), Admiral Nyako blamed the affected state governments for the poor implementation of the scheme in their states.

The arrangement, he said, specified that the federal government should contribute N20 billion, the commercial banks N30 billion while each state is to give a counterpart funding of N200 million, bringing the overall total to over N57

billion. He said that while some state governments have paid their counterpart contribution to the scheme with one of them

even exceeding the target by contributing N1 billion, other states have failed to even set up the implementation committee.

He declined to name the states, although he confirmed that his own state, Adamawa, is among the affected ones.

Admiral Nyako who is also the national president of the All Farmers Association of Nigeria (AFAN), said where the scheme is being implemented well, small scale farmers are getting as much as N5 million each, medium scale N20 million and large scale

farmers above N20 million. He said that his committee can intervene in the states where poor implementation becoming detrimental to the interest of the farmers, adding that the scheme can help to boost agriculture in the country since the loan attracts only eight per cent interest compared to the
