# Birnin Gwari dam collapses, kills 50

1,500 families displaced

t least 50 people are believed to have died and about 1500 houses washed away in the flood that occurred when a Birnin Gwari dam in Kaduna state burst on Saturday after six hours of torrential rain.

Millions of tons of water flowed into Birnin Ruwa. Gusau metropolis of Zamfara state on Saturday morning. The flood struck just after morning prayers.

among the dead, survivors said vesterday.

Seven hundred of the thousands made homeless are camped at a school in Gusau city, emergency agencies confirmed yesterday.

A spokesman for the National Emergency Management Agency (NEMA), said they do not know the whereabouts of the other people washed out of their homes. Ibrahim Farinloye, spokesman of NEMA said: "I can't say where the others could

be. Maybe they have gone to family or friends." He could not confirm how many people had died.

The state governor told newsmen that water behind the dam had reached a critical level following torrential rains, forcing the structure to give way.

Staff at the dam had been unable to open the floodgates. State authorities have put up temporary shelters to house survivors.

Governor Ahmed Yarima called on the federal government to provide aid adding that a tidal surge engulfed the area.

"The body of water was just like the pictures of tsunami that we have seen," he said.

giving amounts to a few cups for each of the 1500 households washed away.

He said photographs of the flood was being passed to NEMA and asked them to respond promptly.

Gov. Sani advised people living near the river bank to

leave the place immediately assuring that government would do everything within its "limited resources" to ensure that they are relocated.

Also destroyed was a large number of houses estimated at about 800, some dom-

estic animals which included cows, sheep, goats and other effects within the affected houses.

The downpour which started at about 12:00pm to 6:00 am, also led to the breaking down of the city's water barrage which made it possible for the water to flow into the houses of the affected people, washing away all their belongings including animals,

One of the victims who didn't want to be identified, said: "Only God knows exactly how many households along with their children have died. It is a terrible thing to happen".

Unconfirmed reports said the collapse of the dam might not be unconnected with the inability of the state's water board officials to open the spillway when water in the dam reached a dangerous level yesterday night following a heavy downpour.

The dam was the main source of water supply to Gusau. Hundreds of villages have been cut off by the flood.

## FG takes Atiku, others to Code of Conduct Tribunal

he federal government has charged the Vice President, Atiku Abubakar, to the Code of Conduct Tribunal sitting in Abuja over allegations of corruption and abuse of office.

The VP was charged along with the former Executive Secretary of the Petroleum Technology Development Fund (PTDF), Hamisu Abubakar and Umar A. Pariya, Personal Assistant to Abubakar.

He was further accused of receiving N250 million as bribe from Mofas Shipping Company owned by Otunba Fasawe. The money was said to have been transferred to a float account in Bank PHB from Trans International Bank.

Also, Alhaji Hamisu Abubakar was accused of unlawfully receiving a reward

of N200 million in form of a loan from Equitorial Trust Bank and a Trucking contract with Con Oil – both companies owned by Chief Mike Adenuga, contrary to section 12 of the Code of Conduct Bureau.
