## 3 killed in Maiduguri violence

feared dead in a crisis between rival 'thug' groups, popularly called ECOMOG suspected to be supporters of the ruling All Nigeria People's Party (ANPP) in Maiduguri yesterday.

Eye witnesses told Daily

Trust that two of the dead were burnt alive while the third was killed and had an old vehicle tyre placed on his body but was reportedly not burnt. The corpses were deposited at the State Specialist Hospital, Maiduguri.

The police spokesman added that the crisis was between rival thug groups of one of the political parties, believed to be the ANPP.

When our correspondent visited the Ngomari-Constain area of Maiduguri where the incident happened yesterday, the vehicle in which two of the dead were burnt was still on the street with blood stains

covering the area.

Shops and places of business were also closed around the area of the incident as people flee for their lives.

The situation was, however, brought under control by armed mobile policemen who were deployed to restore law and order.

Daily Trust was unable to get a comment from the State ANPP Chairman, Alhaji Mohammed Imam. Our correspondent's effort to locate him in Maiduguri yesterday failed as he was said to be attending a meeting reportedly associated with the crisis and his telephone lines

Our correspondent got through to the party Secretary, Alhaji Yusuf Adamu but he said he could not comment because he was out of town at the time.

Daily Trust learnt from eye witnesses, however, that the crisis started around 9.00am yesterday at the premises of

Total filling station on the Lagos Street-Bama Roadjunction, as hundreds of people gather to join fuel queue.

One of the suspected ECOMOG members was said to have tried to enter the filling station but members of a rival group, who also wanted to buy fuel, tried to stop him. The scuffle between them soon snowballed to a crisis, as those who tried to stop the one wanting to get into the filling station began to beat him.

## Court recognises Lalong as speaker

Court yesterday came a step closer to reinstating Simon Lalong as the speaker of the Plateau House of Assembly.

A court of appeal in Jos upheld a case brought by Mr Lalong asking for a court order to stop Michael Dapianlong from taking on the job.

The case started in October after Mr. Dapianlong and five other members of the state assembly were rushed to los by the army to begin impeachment proceedings on

Lalong and other Dariye

loyalists were still in the custody of the Economic and Financial Crimes Commission.

At the appeal court Dapianlong argued Lalong could not bring the case as he had defected to another party. But a panel of three judges led by Justice Kumai Bayang Akaahs disagreed.

A copy of the judgement delivered by Justice Kumai Bayang Akaahs of the court of appeal indicates the three judges of the court gave a unanimous judgement on the appeal.

The two other judges, Justices Rabiu Danlami Muhammad and Mohammed Ladan Tsamiya, agreed with the ruling that the appeal instituted by Dapialong and his five other colleagues, lacks merit and ordered an accelerated hearing on the substantive suit.

A cost of N10,000 was also awarded in favour of Lalong and his colleagues.
