## 12 year old found dead in Makurdi

12 year old girl was found dead a few meters from her home in the Logo One suburb of Makurdi, the Benue state capital.

State police authorities said it was too early to speak on the incident as investigations have just started.

Members of the local vigilante group said they suspect the victim had been raped.

Miss Aondokwagh Agbani was found in a drainage system near her home. Her body was dumped with her legs wide apart, members of the vigilante group said.

But police spokesperson, Samuel Jinadu (ASP), declined comments beyond confirming the incident.

According to him, "it is too early to comment. We are still investigating the cause of the death and those behind it".

The deceased's parents

were too grief stricken to talk to the press, but neighbours said Aondokwagh Agbani attended a traditional marriage with her mother around the neighbourhood the previous night

night.

At a point, the mother asked the deceased to take her younger sister home because she was fired

because she was tired.

Neighbours said the mother waited for her return to the occasion in vain as she could not be found even after a thorough search by

accompanying neighbours.

"She was found only a few meters away from the house only this morning", said a concerned neighbour who however refused to disclose his identity.

He said the deceased was found lying in the drainage system.

Armed policemen who arrived the scene after the report was lodged at the nearby police station, removed the corpse to the Federal Medical Centre where it was deposited in the mortuary.
