Maiduguri kerosene explosions kill two

erosene explosions from four wards in Maiduguri Metropolis, Borno State, in the past weeks have killed two persons and injured four others.

The explosions took place the night when the victims, including two children and four women, were attempting to light their lanterns.

Daily Trust report that four of the victims are in the surgical ward of the University of Maiduguri Teaching Hospital (UMTH). He says the victims are receiving treatments for the burns.

Our correspondent learnt that the two dead victims include a 20 year old girl, Agnes Dickut Musa and a 10-year old girl who died from injuries sustained in the explosion.

Confirming the kerosene explosions, the Zonal Manager of the Department of Petroleum Resources, Alhaii Mohammed Usman, in a telephone interview yesterday, said: "The fire explosions that killed and injured six people were caused by the misuse of kerosene when

lighting either a stove or lantern."

While sympathizing with the victims and their families, he, however, said kerosene supplied from any filling station is "dully tested and certified" by the DPR before it is sold to custom-

He said that people should learn how to properly use kerosene in lanterns and cooking stoves.

He cautioned that any abuse or misuse of kerosene by children and housewives could lead to fatal explosions.

Narrating her ordeal at the hospital, one of the victims, Mrs Okoye, said that on February 9, 2008, she had bought N130 worth of kerosene to cook food for her husband when the lantern exploded with large ball of fire.

She said that she was engulfed in the fire.

lations Officer, ASP Abdul Jinjiri, said "the gang of armed robbers were among those wanted by the police for allegedly killing police officers in Kano."

He said that policemen of the "Operation RUGU-RUGU" team and Ali Kwara's team engaged the robbers, killing three of its members.

He disclosed that the command had been receiving reports of the robbers attacking unsuspecting motorists.

"When the police received the signal yesterday night, police officers confronted them and gunned three of the suspects.

> "After about three hours of fierce gun battle between the police and the robbers, our men were able to over power them. Four robbers were injured but they escaped," he stated.

He said the police recovered one AK47 riffle, two single barrel guns, 26 cartridges, 180 live ammunitions and two motorcycles.

According to him, "the robbers who were killed were among those who killed five policemen in Kano and had changed their base to Jigawa."
