Customary Court in Gwagwalada Friday Adissolved the 16 yearold marriage between a German man, Mr Rolf Schneider

and his Nigerian wife Felicia. The court awarded the custody of the couple's twin children. Juan and Juanita, to the father.

The court, however incred was no there disagreement between the parties and granted Felicia access to the children with the liberty to visit them after giving a 24-hour notice to their

father.

"Felicia has the right to visit the two children of the marriage in the petitioner's residence four times in a month.

"And the visit shall be carried out in a peaceful manner in the interest of the children," the judge declared.

Juwobor said that the children's custody, guardianship and all other responsibilities had been ceded to their father.
