

The Police Public Relations Officer in Abuja DSP Moshood Jimoh confirmed the story and said the Federal Capital Territory Commissioner of Police John Haruna has ordered the arrest of the killer police constable and Vote! He said argument ensued between the deceased over an unknown issue and the police constable carrying a gun went to settle them and accidentally fired the gun.
