Farmer jailed 10 years for killing man over N80

A Maiduguri High Court yesterday sentenced 40-year-old farmer Shettima Matakun of Gumari village in Monguno Local Government Area of Borno State, to 10 years imprisonment for killing one Fema Bulama over N80.

Matakun, according to court documents, was said to have pushed the deceased, Bulama into a pile of wood during a fight over the money, causing him serious injury on the head.

Police witnesses told the court that the deceased was taken to a hospital for treatment, but that he died the following day as a result of the injury.

One of the witnesses, Ali Zakai, said that the deceased gave Matakun N100 to buy him cigarette of N20, but that after buying the cigarette, Matakun refused to return the change. He added that, it was that action that led to the fight between the two.

The convicted man, in his con-

fessional statement to the police, which was tendered to the court, admitted that he pushed Bulama into a pile of firewood, causing him serious injury. But the statement had a different version of what led to the fight.

"He told me to help him collect his N80 from Ali and pay for a drink (illicit gin) he bought. I collected the money and paid for the drink. He later came to me, asking for the money and I told him that I have paid for the drink. But he grabbed the collar of my shirt

and in an attempt to free myself from him, I pushed him and he fell into a pile of firewood and he sustained injury," part of the statement read.

The accused man was charged for culpable homicide.

The judge, Justice Pinder Haruna Ngadda, said the prosecution counsel proved beyond reasonable doubt that the accused committed the offence and sentenced Matakun to 10 years imprisonment without an option of fine.

Chemical Society begins research on Zamfara lead poisoning

THE President of the Chemical Society of Nigeria (CSN), Prof. Felix Okieimen yesterday, said the body has commenced research into the recent lead poisoning incident that claimed several lives in Zamfara State.

Okieimen, who spoke with Daily Trust, shortly after speaking at the opening ceremony of the 33rd annual international conference and exhibition of the society in Abeokuta, Ogun

State, said two groups had been set up for the purpose.

"Two groups have been set up by the society, one, to look at the organic compounds in our society and the other to carry out a detailed study of what caused the lead poisoning in Zamfara State. We hope to find out why and how

such a problem occurred and we are doing it on our own, govern-. ment is not involved. Human beings are responsible for the chemical changes, which are responsible for global warming, flood and desertification. Studies are on-going and by next year, the reports will be made public,"

On the theme of the conference, which is "Green Chemistry and Sustainable Development: Challenges and Prospects," Okieimen said since the concept of Green Chemistry was new to the Nigerian system, it was necessary to draw the attention of the public and government to it.

The Green Chemistry is a new concept, so we are working with countries with well-established laboratories," he added.

Law school students, graduates protest over unpaid scholarships

SOME graduates and current students of the Nigerian Law School who are indigenes of Nasarawa State yesterday in Lafia protested against the state government's failure to pay their scholarship for three years.
