"There is need to have in government people who know what governance is all about and who can handle matters without supervision. You do not start apprentice ship towards the end of a journey. We would rather go for someone we can entrust with certain levels of responsibility so that governance can go on". Responding, the new SSG, Dr. Imuekemhe thanked the governor for the opportunity to serve. He assured that the trust reposed in him would not be betrayed.

### Gunmen kill cop in Rivers

TWO weeks after the killing of six police men in Rivers State, a police corporal has again been killed by yet to be identified gun men in the state capital, the police commissioner, Suleiman Abba told Daily Trust yesterday.

Suleiman Abba in a telephone interview with our correspondent identified the murdered policeman as Corporal Ekere Enuinam, saying he was killed when a group of hoodlums attacked them in an effort to snatch police guns at the weekend. He said the hoodlums who operated in a black jeep were taken on by the Metro Police patrol team, thereby foiling their plan to take the police rifle.

The police said they arrested a suspected kidnapper, Sanga Prince in Ikiri village of the state yesterday when they rescued a woman, Ezekwe Ijeoma, from kidnappers. This came on the heels of another arrest at the weekend of a dismissed soldier, Lawson Amaechi, believed to be operating a gang after they allegedly kidnapped an elderly woman, Jelina Okoroma, in front of her house in Port Harcourt.

# Boy, 13, charged with ing man to deat

THE police in Borno State yesterday arraigned a 13-year-old boy, before a Maiduguri high court for allegedly stabbing a 30-year-old man to death.

The accused who hails from Bolingo village in Bama Local Government Area of Borno State was alleged to have stabbed Mallam

Mohammed Hassan to death.

According to the charge sheet which was read to the boy, he was said to have engaged in a fight with the deceased over a calabash of milk when he stabbed the man on the chest, resulting in serious injury. The man was said to have been rushed to a clinic in the area and was later confirmed dead by doctors and Umaru was subsequently arrested by the police.

Umaru was arraigned before Justice Pindar Haruna Ngadda of Maiduguri High Court 10 for culpable homicide under Section 224 of the penal code law.

When the charge was read, he pleaded guilty and asked for forgiveness, saying he did not intend to kill the man. Justice Ngadda remanded the accused in a home and adjourned the case to July 6 for hearing.
