## Seven killed, 13 arrested as JTF engages gunmen in Borno From Hamza Idris & Yahaya Ibrahim, Maiduguri

SEVEN deaths were recorded as wave of violence and serial killings continued in Maiduguri yesterday, with officials of the Joint Task Force (JTF) saying a suspected member of the Boko Haram sect was killed in a hideout while three armed robbers were also killed during an exchange of fire.

On the other hand, two policemen includ-

ing an inspector as well as a civilian were killed by unidentified gunmen in various locations in Maiduguri.

Spokesman of the JTF, Lieutenant Colonel Sagir Musa said following a tip off, armed security operatives raided a hideout of suspected members of the Boko Haram at Pompomari area in the state capital around 5.30am.

He said one suspect was killed and Ak47 rifles and some materials for making Impro-

vised Explosive Devices (IEDs) were recovered at the scene.

Before then, the spokesman said JTF operatives had raided another suspicious area at Wulari, also in Maiduguri metropolis around 3.30am and cordoned off the whole surround-

"A cordon and search operation was conducted and 13 suspected members of the Boko Haram were arrested and are being investigated now," he said.

He said in the early hours of yesterday, JTF operatives responded to a distress call and rushed to Gomari area where they engaged some armed robbers in a shoot out.

"It was around 2.18am," he said. "The shoot out led to the killing of 3 suspected robbers. One locally made pistol, a dane gun and three machetes were recovered from the robbers,"



# SSS kills man,33, injures brother in Kano

STATE Security Service (SSS) operatives Mond a 33-year-old Kano businessman, Zahraddeen Muhammed Musa, and injured his 18-year-old brother, Usman at Giginyu area in

The incident occurred around 8.30pm, when the deceased and some family members visited a friend's residence near the state SSS headquarters at Sardauna Crescent, relations said.

The deceased's mother, Hajiya Bahijja, who was together with the victims in the car when the incident occurred, said "security men opened fire at them for no reason", as they arrived their destination.

We were five in the car with the two of them, Zahraddeen's wife, Samira and one of our neigh-

bours and just as the deceased they were stopping our car and who was driving the car was trying to park in front of a house we visited at Giginyu, they opened fire at us, killing Zahraddeen and injuring Usman on the neck", said Hajiya Bahijja.

According to her, she noticed that Zahraddeen had died on the spot while Usman was bleeding from the neck injury he sustained and therefore came out of the car in search for help to rush the injured for medication.

When I touched Zahraddeen and noticed he had died already, I immediately thought it was more important to get help for Usman who was seriously bleeding and when I came out of the car, the security men threatened to shoot

me too. I asked them to go ahead. "It was then they claimed that

they had to open fire because we didn't stop. I told them all I needed then was to get m help for Usman and they insisted that they were taking us to the Army hospital along Airport Road. Since we got to the hospital, they have denied us access to seeing him. In fact, they even attempted to seize my phones when I was making calls to notify my family about the incidence as we drove to the hospital," she said.

Hajiya Bahijja, however, said she has submitted everything to Allah but called on the authorities concerned to address the rate at which the security men are killing innocent souls since their deployment to ensure security in the city.

Zahraddeen was laid to rest according to Islamic rites yesterday morning while Usman is on

admission at the Army hospital.

Contacted, Kano State director of SSS Mr. Bassey Eteng, confirmed the incident, saying however that his men shot at the car because it approached their checkpoint at high speed and the driver defied orders to stop.

The director, who said the incident happened around 9pm, told Daily Trust that SSS operatives took precautionary measures, especially against the backdrop of a foiled suicide attempt on the office in January.

"He was warned that he should stop so that they will conduct normal checking but he refused. Warning shot was fired, but the next thing he did was that he turned abruptly. So the operatives thought they were dealing with an offending vehicle and they fired on the vehicle."
