Court remands man for allegedly stabbing another to death

A 35-year old man, Micheal Akpan, who allegedly stabbed a man to death, was on Thursday docked at an Ebute Meta Chief Magistrate Court in Lagos State.

The defendant was arraigned on a charge of murder. His plea was not taken.

The Chief Magistrate, Mr Alex Komolafe, ordered the remand of the defendant pending an outcome of legal advice from the State Director of Public Prosecutions (DPP).

Earlier, the Prosecutor, Insp. Cousin Adams, urged the court to remand the defendant in a custodial centre for 30 days, pending legal advice. Komolafe granted the request of the prosecutor.

Adams alleged that Akpan had used a knife during an argument to stab the deceased, Daniel Nse, to death on January 2, at about 10.00 p.m., at ldi Araba. The case has been adjourned until February 17, pending receipt of advice from DPP. (NAN)
