FATAL MOTOR ACCIDENT: ON June 19, 2006, at

about 064hrs, there was a report at Elere Police station that a Volkswagen mini-bus with Reg. No. XM 726 EKY driven by one Taofeek Rasaq 'm' of No. 27, Abeje Street, Moricas Agege, ran over a commercial motorcycle (okada) operator one Semiu Adebulu 'm' of No. 9, Akinleye Street Orile Agege and his passenger one Mutaila Muili 'm' of No. 7, Isheri Road, Ogba. The victim died on the spot.

Similarly, on June 19, 2006 at about 0600hrs, there was a report at Apapa Police station that a Mack Tipper Truck with Reg. No. XE 883 NEN driven by one Obom Ibe 'm' of No. 13, Kosoko Street, Ayetoro Ijanikin ran over a female passenger one Josephine Ini Ekwere of No.115, Idowu Street, Olodi Apapa, who she fell down from a moving motorcycle with Reg. No. QK 356 AAA ridden by her husband name yet unknown at Tin-Can Island First Gate along Apapa-Oshodi Expressway. The victim died on

Finally, on June 19, 2006, at about 003hrs, there was a report at Oko-Oba police station that a yet-to-be identi-fied driver of Nissan Pick-Up Van with Reg. No. AS 362 AAB ran over a pedestrian, one Bosun Sanusi 'm' 36yrs, old of unknown address at Oja-Oba bus stop along Abeokuta Expressway. The victim gave up the ghost on the way to the hospital. Traffic policemen from the respective stations visited the scenes and corpses were removed to the public mortuary for autopsy. The cases are under

ARSON/WOUNDING: ON June 19, 2006, at about 0700hrs, there was a report at Oke-Odo police station that one Albert 'm' other name and address yet unknown, a security man guarding a shopping complex at Katan-gowa market, set the complex and many shops ablaze, one Peter Olameforo 'm' address yet unknown who was pre-venting Albert was inflicted with deep matchet cuts.
