trapped him in his desperate attempt to save one of a set of twins. The child. Kehinde, died. Equally lucky was Mr. Onu Agba who sustained a minor injury on the fore-

head. Agba told The Guardian yesterday: "It was a trauma nobody envisaged. If not that my family travelled home, perhaps, they would have been trapped. I owe my escape to God."

The bodies of five more dead bodies were pulled out of the rubble yesterday. According to rescue officials at the scene, four lifeless bodies, three ladies and one man, were recovered in the early hours and the fifth was pulled out in the afternoon. Still recovering from the

shock, one of the survivors. Abike Odushola who occupied a shop in the building. cried to the government for help as all her dreams of livelihood had been lost through the incidents. She said: "I want to thank

almighty God for sparing my life, because I would have been among those people that were dead in the incident. My sister occupied two shops there, she was using one as hair dressing salon, selling cosmetic materials and the other one for video cassette and compact disk rentage. now, everything is But gone. Our means of livelihood is gone. So, government should please come to our rescue."

Miss Abike put the worth of the materials she lost to the incident at N200,000.00.

Alaba Odediran, a lady survivor told *The Guardian* that the occupants of the building had earlier complained to the landlord about the poor state of the building.

"We learnt that the building was approved for only two-storey building, but the man went ahead to erect a 36-flat, four-storey build-

ing with about 20 shops.
"When we were about occupying the shop about four years go, we didn't really appreciate the condition of the house. But because we were in a hurry, we had no option then."

we had no option their. She continued: "We complained to him about last month when he came that sometimes, we could not close the door very well, sometimes when we were sweeping the floor, it would begin to produce some unnecessary dust and so on. He said okay, that he would find something to do."

The Lagos State government has ordered the immediate sealing off of House Number 46, 49 and 77B of the Bola Street.

The building were said to belong to the owner of the collapsed building.

The Lagos State Police Command will in two weeks time submit its report on the remote cause of collapse. The state Commissioner of Police Mr. Emmanuel Adebayo and the Deputy Commissioner of police incharge of the State's Criminal Investigation Department, Panti, Yaba, Lagos have invited the developer of the building and some residents of the area for questioning.

The State House of Assembly has also ordered general audit of all buildings in Lagos, to ascertain their safety for habitation and approvals for individual construction.

The Assembly, which passed this resolution after debating on the collapsed building, further directed the State Ministry of Physical Planning and Urban Development to embark on general audit of buildings to establish whether they comply with building planning law.
