A JOINT team of the military and police officers has been deployed in Nnewi area of Anambra State, which was at the weekend gripped by violence.

The deployment was at the instance of the governor, Mr. Peter Obi, who has had to grapple with multiple incidence of violent eruptions in the last one month.

Obi, in a state broadcast

The force Public Relations Officer, Mr. Haz Iwendi yesterday confirmed that buses and a consignment of military camouflage had been seized from suspected hoodlums.

According to him, the joint military and police task force are on trail of the fleeing suspect that on Sunday attacked a

police station at Nnewi. Giving more insight into the cause of the mayhem the police spokesperson said: "Over 300 hoodlums attacked the station

with dangerous weapons. Five of the attackers were shot dead and two policemen, a sergeant and inspector were killed and many other policemen

injured."
Iwendi added that the Inspector-General of Police Mr. Sunday Ehindero, had ordered manhunt on the fleeing attackers.

confirm the actual number of suspects arrested but disclosed that many were already in police net.

The inspector-general of police held a security meeting with top officers yesterday in Abuja calling for better security across all the police commands in the country.

Against the backdrop of the attack, Governor Obi disclosed that more major towns in the state had now been brought under protection and surveillance of the security operatives.

In the state broadcast. Obi reiterated the commitment of his administration to stamp out all forms of brigandage, thuggery and anti-social behaviours. He said: "Government has lined up a number of programmes and projects to occupy the attention of skilled young, and unskilled Anambrarians so that they do not go into crime on account of idleness".

The chairman of the state council of traditional rulers and Igwe of Nnewi, HRH Kenneth Orizu III, condemned the torching of the police station. The monarch urged his subjects to report any suspected trouble maker at once to his palace or nearest police station.

Also, two other groups from the town- Nnewi concerned citizens, and Ife Nnewi, in press statements condemned the assault on the police and the community.

They blamed the police for being lax, saying, "If the police had been alert to their duty, they would have detected the crime and nipped same in the bud". The two groups claimed that the hoodlums were known to have perfected their plans to strike at the home of citizens of the town before launching out.

The documents which were signed by Chief Stephen Odobulu, (president) and Mr. Goddy Adibe secretary urged the perpetrators "to desist from importing and dispensing violence on the commercial city of

Nnewi".

in place to ensure the hoodlums leave the state completely, Obi said that the hit-and-run guerilla pattern now being used showed that "We have forced them out from completed buildings, to uncompleted buildings. Meanwhile, the All Progressives Grand Alliance [APGA] yesterday alleged that the current violence in Anambra State, was being masterminded by some politicians with a view to instigating the Federal Government to impose emergency rule in the state.

The party therefore, vowed to resist any attempt to suspend the

democratically elected government of Mr. Obi, and urged the Federal Government not to succumb to any pressure to impose emergency rule, It noted that Onitsha had become calm with citizens going about their businesses without fear.

Addressing journalists in Enugu, National Chairman of APGA, Chief Victor Umeh noted that the incident at Nnewi calls for the need for a mop-up operation by security agents against those behind the attack. He also denied specula-

tions that he had parted ways with Obi, saying that he has enjoyed a cordial relationship with the governor, while at the same time, the party had given the governor an open hand to run the administration of the state the way he wished. Umeh said: "Onitsha which was the major flashpoint for the past two months has regained normalcy: people now mind their businesses. It is not surprising that the hoodlums who seized the motor parks operating under NARTO have relocated outside the city. They have taken their activities to Okwulobia and Nnewi. The Federal Government needs to

direct a mop-up operation in these new areas where the renegades have relocated to."

According to Umeh, the

seizure of the parks by the National Association of Road Transport Owners[NARTO] has denied the state government of funds running into billions of naira, adding that despite being outlawed since last year, the NARTO members were still operating in the state.

The APGA boss who spoke further on the

The APGA boss who spoke further on the attacks, said it had a semblance of what was meted out to supporters of the party during the 2003 general elections when "sponsored persons in military uniforms unleashed attacks on party faithful in an attempt to rig the elections".

He tasked the Anambra

State Commissioner of Police, Mr. John Haruna, to "carry out thorough investigations of those who owned the vehicles that were used in the Nnewi attack and how they (the vehicles) were procured for the attack, He added that the flags of the Movement for Actualisation of the Sovereign State of Biafra [MAS-SOB] used by the thugs during the Nnewi incident were meant to

hoodwink the public into thinking that it was the ethnic nationality group that was behind the violence.

He exonerated MASSOB from the violence, saying the organisation has no financial interest Anambra State which has been eroded by the present administration in the State. "People should wonder why the same violence is not going on in Owerri, MASSOB headquarters, Aba, Enugu and other places with MASSOB elements. All those with genuine grievances should abandon violence and table their problems with the governor who is willing to listen," he stated.

Umeh expressed confidence that the governor would emerge victorious at the end, while restating that there was no going back on the measures already taken to curb activities of miscreants in the state.
