Funso Williams assassinated

A NOTHER gruesome killing raised the political temperature in Lagos yesterday.

Third-time aspirant to the state's governorship seat, and Peoples Democratic Party (PDP) chieftain, Engineer Funsho Williams, lost the desire to achieve his dream to cold-blooded murder. He was strangled to death at his 184B Corporation Drive home in Dolphin

The captain from school to politics

FUNSHO Williams was born on May 9 1948 to the late Olu Williams (KCOB), who served the Nigerian Railways for over 30 years Ibidun (QCOG), alias Mama Red Cross, who is now about 85 years.

He attended St. Paul's Roman Catholic School. Ebute Metta (1954); St. Gregory's College, Obalende (1962), the University of Lagos (UNILAG) (1968) and New Jersey Institute of Technology

At schools sport, Williams excelled in shot put when in 1964, he represented Lagos at the Hussey Shield Competition in Enugu. He later became the undisputed schoolboy champion in both the Shot Put and Discuss events at competitions staged in Lagos, Warri Ibadan, Kaduna for four consecu-

In Form Three, he broke the 50-feet barrier in the Shot Put. In 1968, he became the captain of the Lagos State Secondary School Hussey Shield Track and Field team and put up a fivestar performance.

Today, his "The Captain" nickname in political circles of Lagos was as a result of that per-

Williams won two gold medals in Shot Put and African Universities Games in Sierra Leone.

Estate, Ikoyi, Lagos. His wife and children were said to have travelled to London last week.

The death has added to the long list of curious murders in Nigeria since the return of civil rule in 1999.

The assailants left no doubt that their mission was to take the life of the prominent engineer and politician in a most violent manner. They tied

Another member of the family, amidst tears, informed The Guardian that the assailants never gave their victim any opportunity although he pleaded with them for mercy.

It was learnt that seven

people, including four policemen, one political aide, two security details and his cook in the house have been arrested by the police.

Another confirmed to our reporter that as at the time the assailants entered Williams' bedroom, none of the four mobile policemen guarding him was around.

This, according to sympathisers, is reminiscent Attorney-General of the Federation and Minister of Justice, Chief Bola Ige (SAN), was assassinated in 2002.

Thousands of his supporters and party loyalists thronged the house, wailing and raining curses on the suspected assassins. Some of the supporters, who wore the deceased's

Nigeria's long list of curious deaths

THE list of suspected political killings in Nigeria, since the return of civil rule in 1999, is long; very long. In all the cases, neither the killers, nor their sponsors have been brought to justice.

The most prominent of them have been the gruesome murders of the then Minister of Justice and Attorney-General of the Federation, Chief James

Ajibola Ige, on December 23, 2001; the National Vice Chairman (South-South) of the Peoples Democratic Party (PDP), Chief Aminosoari Dikibo; a chieftain of the All Nigeria Peoples Party (ANPP), Chief Marshall Harry; and a couple, Barnabas and Abigail

There were also the unresolved murders of

Mr. Victor Nwankwo, younger brother of prominent politician, Arthur; Ogbonnaya Uche and Theodore Agwatu, among others.

The killers of Ige literally waltzed into his home as his security operatives were conveniently away. Some of the assassins, at gun-point, herded the then minister's household

Lagos bans rallies, offers N10m for information on assassins

FOR any veritable clue to getting the assassins of Chief Funsho Williams, the informant would get N10 million. The reward price was yesterday by State Governor Ahmed Tinubu while banning political rallies for two weeks in

Tinubu, who described the manner of Williams' murder as "barbaric and gruesome," told reporters at his Alausa office that the perpetrators would not be allowed to get away with deed." "this evil

The governor condoled with the bereaved family, especially the widow and his children, and pledged that everything possible would be done to ensure that Lagos State is not turned into a war zone.

"I assure Lagosians that everything will be done to unravel the mystery surrounding this dastardly act and bring the perpetrators to book". He said the government and people of Lagos State hereby call on the Nigeria Police and other security agencies to move speedily to unravel alleged murder before the perpetrators erase their trails.

Tinubu enjoined politicians and leadership of all political parties to embark on re-orientation of their members on the virtues of politics without hate, harassment and blood spilling. If indeed all we seek to do is to serve the people, then we

should not engage in acts which can undermine the democratic process.

The governor was emphatic that political gangsterism, violence, annihilation and immolation will not be tolerated in Lagos State.

'We cherish our peace, tranquillity and economic progress. We shall miss Engineer Funsho Williams because of the virtues that he demonstrated", he declared.

The governor proceeded to ban all political rallies in the state for the next two weeks to honour Funsho Williams.

Tinubu charged the Nigerian Police to rise up to the challenge by unravelling the perpetrators of the murder, as it would be one of the major planks on which

lists benefits of multi-party system

FORMER Military Head of State, Gen. Yakubu Gowon (rtd), yesterday declared that true democracy could only be achieved under a multi-party system where various national interests and groups could find a platform for expression.

Reviewing how the country evolved from the colonial period through independence to the present democratic dispensation, Gowon declared

that part of the recurrent political problems facing Nigeria originated from the amalgamation of 1914, which, he said, the colonial rulers carried out without dissolving the individual characteristics of the different components into one. Gowon aired his views

at the first convocation lecture of Covenant University, which took place at Ota, Ogun State, yesterday. The lecture was

titled: "Issues of Governance for Nation States of Africa; Pathways for Leadership Development.

According to him, a true multi-party democracy must clearly distinguish between the party and the government, and it must respect the wishes of the

people.
Gowon argued that

since legitimacy is one of the products of effective governance, it can never exist where there is extensive personalisation of power, denial of fundamental human rights. widespread corruption, prevalence of un-elected structures, disrespect for the rule of law and unaccountable government.

To him, legitimacy is not only about ascension to power, but also how power relates to the people who have voluntarily surrendered it and offered support to the leadership in place.

The former head of state counselled that in determining who to elect as a leader, the electorate should look for the combined qualities of high morality, self-confidence, charisma, good character, commitment, compe-

tence, courage and focus. Other qualities to be desired, he said, are gen-

erosity, initiative, security, willingness to learn, ability to teach and instruct, compassion, vision and humility.

Gowon said: "A good leader's thought must continually be about the good of the people, asking himself the question whether what he is doing and the laws he is making for the society are fair and just. The leader

He noted that the state had not witnessed any political killing under the present political dispensation and said that this ugly trend must be arrested if politicians still intend to go before the electorate to seek votes.

The political terrain in the state was tense yes-

terday following the gruesome murder. The Inspector-General Police, Mr. Sunday Ehindero, arrived in Lagos at about 4 p.m. and ordered the arrest of the two policemen stationed at the gate of Williams' residence and a personal

Shortly after visiting the home, Ehindero called an emergency meeting in his official residence at Queens Drive also in Ikoyi, which was attended by the Assistant Inspector-General of Police Zone 2, Mr. Adedayo Adeoye, the State Commissioner of Police, Mr. Emmanuel Adebayo and other top officers from Abuja and Lagos.

Report filtered last night that protesters stormed the residence of a known opponent of the late Williams, to set it

The IG therefore directed the commissioner of police to deploy mobile policemen to beef-up security in the entire Victoria Island and the residence of Williams. Force Public Relations Officer, Mr. Haz Iwendi, spoke to journalists on the murder. He said: "Engineer Funsho Williams was strangled to death. He was not

hands were tied until he gave up the ghost.
"This happened

between the hours of 11p.m. (Wednesday) and yesterday morning; the two policemen on duty have been arrested for interrogation."

Police sources told The Guardian that some politicians might be quizzed over the murder.

Giving more insight into how police might investigate the case, Iwendi said: "We are working on many leads because there was information that last night (Wednesday) that the late Williams received some of his party members at about 11p.m and this was the exact time the incident occurred."

He, however, refused to speak more since he has taken over investigation.

The late politician's last public outing was on Wednesday, when the meeting between PDP members and the AIG Zone 2, Adeoye, held over the many crises of the party and threat to peace. The police boss admonished them to eschew violence ahead the coming elections.

A large crowd of supporters besieged Williams' residence. They all wailed endlessly. One of the tearful voices said: "They have just killed the man who would have turned Lagos into better place.

As a result, he was among the first set of inductees into the UNI-LAG Sports Hall of Fame in 2005.

His sports exploits did not affect his academics. He left secondary school with seven Alphas and had three passes in Science at London University "A Levels", in Lower Sixth Form in 1967.

As a kid in Ebute Metta, Williams mingled with children of different ethnic, religious backgrounds and status. And he had as friends the likes of Wilfred Imoudu (Edo State), Anthony Boyo (Delta State) and Fola Daniyan (Niger State), Kalu Idika Kalu, Philip Asiodu, Helen Boyo (now Mrs. Alex Ekwueme) and her brother Monsignor C. Boyo and Cyprian

Ekwensi.

It was not therefore surprising that he ended up marrying someone from Ndoni in Rivers State. Last year, his second son married Walter Ofonagoro's daughter, who is from Amaigbo in Imo State.

Fresh from America in 1974 after his Masters Degree, Williams joined the Lagos Civil Service. By the time he retired in December 1991 as Director-General (Permanent Secretary), he had been for 12 years the team leader responsible for the construction of about 70 per cent of Lagos State roads and bridges.

As a grassroots politician, Williams was used to networking. His political machine, the Network Alliance, was as at various times in the defunct United Nigeria Congress Party (UNCP), the Alliance for Democracy (AD) and now the Peoples Democratic Party (PDP).

In the UNCP, the structure produced about 30 of 40 members of the Lagos State House of Assembly that never sat. And in the AD in 1999, most of the House of Assembly members cut their political teeth in the Network Alliance.

Williams decamped to the PDP along with his followers on February 17, 2001 at the Tafawa Balewa Square after alleged maltreatment in the AD.

Attempts by reporters to gain entrance into the house were stopped by policemen who said that they were carrying out forensic tests on the body.

A sympathiser, who gave his name as Olanrewaju Sarumi, said: "The state chairman of the PDP celebrated his birthday on Wednesday after which he came home and had a meeting with his campaign organisation until about 2.00 a.m. before going to bed."

The late Williams decamped from the Alliance for Democracy (AD) to the Peoples Democratic Party (PDP) after losing the AD's governorship ticket to Senator Bola Ahmed Tinubu in the 1999 elec-

He was the PDP's governorship candidate in 2003 and lost again to Tinubu and was still gunning for the post before the violent mur-

der yesterday.

The Deputy South
National Chairman of the PDP, Chief Olabode George, yesterday ordered the cancellation of the party's political rally slated for Eti Osa Local Council.

George also summoned an emergency meeting to fashion out the next line of action.

The Inspector-General of Police, Mr. Sunday Ehindero, flew in from Abuja yesterday afternoon at about 3.00 p.m. With the Lagos State Commissioner of Police (CP), Emmanuel Adebayo, Ehindero joined other sympathisers who trooped to the house of the deceased.

There had been attacks and counter-attacks by supporters of PDP governorship aspirants at Badagry, Ikorodu and Kosofe recently.

Williams joined politics after his career in state's civil service in the 90s. He was a staunch member and the governorship aspirant in the defunct United Nigeria Congress Party (UNCP).

As at 3.00 p.m. yesterday afternoon, the Dolphin Estate home of the late PDP chieftain had been sealed by heavily armed mobile police-

Police vehicles were parked at strategic points, keeping at bay vehicles that usually passed through the estate. Cars formed a long queue along the usually busy Osborne road. The atmosphere that pervaded the entire compound and the adjoining streets leading to the house was that of shock, apprehension and subdued anger.

James Ibori is saddened by this dastardly act

which, he said, was unacceptable. He called security agencies to track down the perpetrators. He noted that Nigerians must be vigilant as "we get into an election year.

The Ogun State Governor, Otunba Gbenga Daniel, described Williams' death as a devastating blow to Nigeria's democracy.

Daniel, who said the news was broken to him at an official engagement, described the act as an extremely dangerous dimension to security of lives in the country.

The governor, in a statement signed on his behalf by his Senior Assistant on Information and Strategy, Mr. Sina Ogunbambo, described the deceased as a perfect gentleman, a refined politician an accomplished technocrat, and an ardent believer in the cause of democracy.

He said: "The

deceased was a dogged fighter in his noble aspiration to become the Governor of Lagos Lagos State."

Daniel tasked the security agencies not to leave any stone unturned in unmasking those behind the brutal murder.

He commiserated with President Olusegun Obasanjo, the bereaved family and people of Lagos State.

An AD legislator from Lagos State, Senator, Tokunbo Afikuyomi, said that the manner of killing was a pointer to

the fact that the PDP was full of dangerous politicians. "Today, the dark veil of

gloom has again been drawn over the Nigerian polity with the mindless assassination this morning of a PDP gubernatorial aspirant, Engineer Funsho Williams, at his Ikoyi residence Lagos", Afikuye Afikuvomi declared in a press statement.

He continued: "I write on behalf of the leaders and people of the Lagos West Senatorial District to express our condolences to the families of the deceased, whose life was perhaps an epitome of decency and restraint in the art of political engagements."

Expressing dismay at the murder, the Senator said: "It is still indiscernible why anyone or group would imagine and visit such violent act on a man who played politics with dignity and respect for the dissenting views of others. Today, the agents of death within the PDP have vindicated Nobel Laureate, Prof. Wole Soyinka that the party is indeed nothing but 'a nest of killers'.

Afikuyomi added: "I respectfully demand that the Inspector General of Police, Mr. Sun-day Ehindero will honour the soul of the murdered politician by speedily tracking down his killers and bring them to justice rather than populate the data

base of unresolved political assassinations with yet the murder of Engineer Funsho Williams.

"Nigerians have not forgotten the many unanswered questions still raised by the brutal assassinations of the late Justice Minister, Chief Bola Ige, Aminosari Dikkibo, Harry Mar-shall, the Anambra State NBA Chairman, the Kogi State PDP Chairman and other notable citizens during the ignoble reign of the PDP."

The Oyo State government reacted in a similar manner. A statement by the special adviser to the state governor, Mr. Diran Odeyemi, described Williams as "an enigma and a political icon whose horizon was cut short by evil people."

Odeyemi said that the governor, Adebayo Alao-Akala called on security operatives to ensure that "the planners and executors of Engi-Williams are neer unmasked."

The governor was further quoted as calling for an end to political killings.

"There is need to put political killings to a permanent stop else, Nigeria's politics will remain a dirty game where decent men and women will not like to participate" Alao-Akala observed.

He prayed to God to grant the late Williams eternal rest and forgive him all his sins.
