## Woman of courage dies in the bush

• Monarch, villagers accuse local 'terror' of the murder

NOT many women are bold enough to confront men even when they know that the men had trampled upon their right.

Any so, it was a spectacle recently when a popular cocoa and kola nut farmer in the sleepy town of Ijare in Ifedore Local Council, about eight kilometres from Akure, the capital of Ondo State, Mrs. Dorcas Alatise, confronted a local oppressor in the area.

But her gallantry, instead of emboldening other women to be able to take up the gauntlet in the future, had turned out a frightening prospect because Alatise lost her life allegedly to the man who is known as a local terror.

The journey of the 69 year-old businesswoman to her untimely death started sometime in February 2006. She had courageously confronted a 32 year-old timber contractor, who had been allegedly going to her cocoa-farm at Igboiti to fell timber, which were said to have been destroying many cocoa trees in Dorcas's farm.

But Dorcas was attacked and slaughtered on September 28. Her body was found on September 30. It took the police of the State Criminal Investigation Department (CID), Akure, a week to arrest the suspect who was alleged to be behind the incident as the police in Ijare

Town could not apprehend the tough man.

The man is feared in the town. He is said to be a source of worry to many farmers in the area because of his activities, which have caused some residents to sue him to court many times in the past.

The Guardian gathered that the suspect, who is now cooling his heels at the state CID, had allegedly been going to the deceased's farm regularly to fell timber. He had refused to pay compensation for crops destroyed.

The forest guards reportedly informed the dead woman who damaged the cocoa crops. The guards told Dorcas that the man had approached them several times for the stamping of the trees felled in her farm.

The deceased thereafter reported the matter to the police at Ijare. She demanded for compensation from the suspect. She also wanted the police to invite and caution him to keep clear of her farm.

But on getting to his house, the suspect was enraged and questioned the woman's audacity to bring policemen to his house. It resulted into an argument between him and the woman. It was gathered that the woman was thoroughly beaten in the presence of the police.

It was further learnt that the Olujare of Ijare, Oba Adebamigbe Oluwagbemigun, organised for the woman to be taken to the hospital when the matter was reported to him. He even paid the hospital bill.

The police later arrested the man and charged him to court at Igbaraoke. He was remanded in prison custody at Olokuta, Akure.

On his way to the prison, he reportedly told the family of the deceased, who was then hospitalised after the beating, that on return from prison, he would not like to meet her again in the town.

True to his words, few days after his release from prison custody, the suspected assailant was said to have traced the woman to her banana plantation, which was acquired by her son to build a house, and allegedly hacked her to death in cold blood. It was learnt that the body of Dorcas

was found three days after she was declared missing.
Oba Oluwagbemigun who spoke with *The Guardian* on the incident at his palace said everybody in the town was fed up with the man.

Before I assumed the throne of my fore fathers, I was told about the robbery activities of the young man who had became a terror to us in the town. I can say that he is

a thorn in our flesh", he said.

He added: "After taking the staff of office, I called him and I pleaded with him to stop all the nonsense he engages in I also called his mother and told her to warn her child to desist from the nefarious activities he has been known for in the town and they all agreed with me and they promised to turn a new leaf. They also promised to ensure peace in the town", the traditional ruler said.

The suspect rather than change for the better, he was said to be involved in new robbery cases and he even confessed that he has a gang that works for him when I called him again", he said.

According to the monarch, the suspect had also been allegedly involved in a case where two farmers were cut with machetes. When the man came back from the farm, he told the relatives of the two victims to go take the bodies of their fathers at the farm. Unfortunately, the victims

survived the attack and they are living witnesses today.
"We have been living in fear of being attacked by the young man and whenever he is in the town, my people are in trouble because the police at

Jare town are afraid of him too. He is a terror in the town and he is always going round the town looking for whom he will devour", he said.

The royal father said the man "has confessed to me several times that life is empty to him. Then I asked myself, what does it take for someone to say that his life is empty, what kind of person would actually say that? And I actually looked around him, nobody could be referred to as his relative(s). He has been abandoned because of his bad character. He has no farm of his own, rather he lives on other people's sweat.

"I have advised him several times that I believe the worst experience or condition can still be converted into something positive. Rather to take to the advice, he has

been involved in one case or another", the monarch

Speaking on the deceased, he said if the suspect is interrogated very well, he will confess and that he is 100 per cent sure that he has a hand in the death of the woman.

"I paid for the hospital bill when he initially beat the woman into a state of coma and I was informed when he threatened the life of the woman shortly before he came back from prison. Enough is enough; we don't want him in our town again. Since he was arrested on October 3, peace has returned to the town and the incessant robbery cases we used to have in the town have stopped"

A relative of Dorcas, Mrs. Victoria

Oguntuase, who also spoke with The Guardian, said the woman left home on that faithful day to work on her banana plantation where she was murdered

According to her, the suspect truly did what he said when he visited her residence at No. 4, Ilemo Street, Ijare that she, Victoria, should tell Dorcas to pack her belongings

and leave the town or else she would meet her waterloo.
"I can say categorically that he was behind the death of my sister and he should be prosecuted according to the law of the land. It is a pity that the man has become a terror in the town and truly he carried out his threat and I know that this would be his last killing in the town", she

But the mother of the suspect, Omobomiwe, stoutly defended her son's character saying that he is a humble

man who could not hurt a fly how much less killing a human being.

According to her, her son has since left timber felling for palm wine tapping as known to everyone in the town.

"Also, since the day the deceased fought with my son, which coincided with my husband's burial, Dorcas has not allowed me and my son to move freely in the town. She has been raining abuses and courses on us and I have sent people to beg her, to no avail.
"The situation degenerated to the extent that we can no


longer move freely again in the town because every eye is on us. It seems we are under bondage despite the fact that my son paid for her hospital bill amounting to N3,500 and not the traditional ruler as widely speculated.

"My son can not hurt a chicken, what then would push him to slaughter a human being? People of the town are only lying against him, just to nail him to the cross", she

Omobomiwe added that her son was coming from his palm wine farm when he was arrested by policemen from Akure alleging that he was responsible for the killing of the deceased and since then nobody in the town has come out to assist her in effecting his release.

She pleaded with the police in the state to release her son because he is innocent of the murder.

Speaking with the state Police Public Relations' Officer on the matter, Mr. Adeniran Aremu, confirmed the arrest, adding that the police were still interrogating the suspect and that he would be prosecuted soon.
