Ogoni Clash Claims 10 Lives, Over 200 Houses

HE renewed bloodletting in Ogoniland Rivers State continued at the weekend with 10 persons feared dead and 200 houses razed by armed rampaging

youths in Mogho. Also, yesterday, Mr. Gabriel Pidonsom, a lawmaker representing Gokana Constituency, incurred the wrath of Bodo armed gangs for failing to support the

were quickly pointed at neighbouring Bodo. Infuriated by the murder of the old woman,

irate Mogho youths Indigenes of Mogho went on rampage. They blocked the road leading to Bodo and bru-

talised anyone identified to be from there. But the crisis turned into a full-scale war on Thursday when Mogho youths alleged killed a commercial bus driver at Kpor, the council's headquarters.

However, the Rivers State Commissioner of Police, Felix Ogbaudu, told The Guardian that scores of anti-riot policemen had been deployed to the area to forestall further escalation of the crisis, which has rendered hundreds

"After Friday's killings and destruction, Bodo youths returned yesterday (Saturday) and burnt down over 700 houses, including that of the paramount chief.

Narrating his ordeal, lawmaker Pidomson, who hails from Bodo, said his relations were

killed and his father and uncle's houses razed because he refused to support the attack on the neighbouring community.

"Bodo is about five times the size of Mogho and I told my paramount ruler that I could not join in the invasion of Mogho because I am a representative of the people," he said yesterday in Port Harcourt. "Bodo people went to

neth Kobani, who is hails from Bodo, has also condemned the attack on Mogho. He said he was terribly appalled and terrified at the scale of destruction and violence that had taken place in the two Ogoni communities. "It is shameful," he said. "Evil has permeated our society. The security agencies should inter-

agencies should intervene. Whoever is responsible for this mindless destruction must be found and dealt with.

"We have spoken to youth leaders. This is madness. Nobody in his right mind will condone these mindless killings. Those who are involved in this callous outrage should be brought to book."

Ogbaudu confirmed the destruction of houses and killings, but could not ascertain the number of those killed.
