along the Katsina Ala, Gboko road in Benue State as four students who travelled to write the University Matriculation Examination (UME) died in a ghastly motor accident.

The bus they were travelling in collided with a Toyota starlet car.

An eye-witness said that several other occupants of vehicles sustained varying degrees injuries, with the corpses of the deceased deposited at the General Hospital, Katsina Ala, while the injured are still receiving treatment at the same hospital.

The Guardian gathered that the students who were traveling to different towns around Katsina Ala boarded the bus at the Katsina Ala bridgehead late in the evening after the examinations. It was learnt that the trip was smooth until the bus got to the Ugbema-Gboko road, when the car, which was trying to avoid a pothole, ran into the bus.

The number of deaths would have been more but for the quick intervention of villagers around the accident scene, moved in swiftly to rescue the passengers.

The Katsina Ala-Gboko Federal Highway has become a death trap in recent times, due to the several potholes on the road, forcing motorists to avoid them, only to find themselves on the wrong lanes of other drivers.

ANPP suspends Imo guber candidate, Azike

The statement which was titled: "Suspension of Chief Ziggy Azike from ANPP" and dated May 4 which was read intermittently on the Federal Radio Corporation of Nigeria (FRCN) F M heartland, Owerri, it stated in part: "ANPP Imo state chapter has viewed with dismay the anti-party activities of Azike contrary to the provisions of the constitution of ANPP and therefore has suspended him from ANPP with immediate effect. 
up to investigate the anti party activities against him and some other party members."

Ajumbe said that as at the time of press Azike was yet to pay his N2 million nomination form and N600,000 fees despite haven been written to by ANPP to pay all his dues.. He also recently congratulated the Imo state Governor elect, Chief Ikedi Ohakim.
