5 Killed As Militiamen Invade Community

TIVE persons are Freared dead following militiamen's invasion of Ivortvom Village in Yooyo ward of Katsina Ala local council of Benue State at the weekend.

The village, located after River Hovo, witnessed massive shooting, as the militiamen numbering about 60 stormed the community.

The armed men reportedly got information that the leader of a rival miligroup, popularly called 'Ghana' was taking refuge in his mother's home in the village.

Ghana is on the wanted list of the Benue State Police Command for leading one of the most vicious militia syndicates in the Tiv-speaking areas of the state.

It was learnt that before the group of militiamen , got to Ivortyom Village, Ghana and his group had got information on the invasion and fled the village.

The invading militiamen consequently burnt down the homes of Ghana's mother and other relatives within the compound.

They went further to shoot at unarmed persons found in the compound at the time of their invasion.

The Guardian learnt that the last week had been difficult for the residents of Ivortyom and neighbouring villages, as militiamen operating in the area had resorted to robbing market women on their way to or from the local markets to sell

A community leader in Ivortyom Village, Mr. Richard Abu, told journalists that the people of the area were devastated by the magnitude of the destruction carried out

by the militiamen.

He said: "These militiamen have grounded social and economic activities in the area in the last two weeks. The invasion at the weekend is the worst because they killed five persons."

Abu stated that politicians worsened the situation by maintaining the militiamen in anticipa-

tion of the forthcoming elections.

He called on the State Police Command to permanently post personnel along that axis to check the regular attacks by militiamen fighting for supremacy.

Contacted, the Benue Police State Commissioner, Ibrahim Mohammed, said that he was yet to receive the details of the attack from his operatives on ground

in Katsina-Ala.

He said that he would release the details to the media as soon as he received a comprehensive briefing from his men.

It would be recalled that last December, some lives were lost at Tor-Donga on the same axis when the Ghana group clashed with other militiamen after a political meeting between two top politicians in the area.

Criticism Trails Swearing In Of Sole Administrators

The recent swearing in 1 of 27 local council sole administrators Governor Ikedi Ohakim of Imo State, has been criticised by an ex-lawmaker.

Speaking to The Guardian at the weekend, Mr. Oliver Enwerenem, who served eight years in the Imo State House of Assembly, faulted the appointment of administrators in the councils, describing it as "undemocratic and a rape of democracy."

He cited relevant sections of the constitution, which would make it impossible for governors to appoint council chairmen in such a manner.

"Another set of undemocratically appointed chairmen has been sworn in today. It is unconstitutional and a rape of democracy and a denial of peoples' right to elect their leaders. How will state governments feel if the National Assembly dissolved them and set up sole administrators to govern their states? The National Assembly should amend Section 7 of the Constitution to withhold funds to any council
