#### Gunmen kill police officers in Rivers

YET to be identified gunmen yesterday attacked police officers stationed under Eliozu flyover in Obi/Akpor Council of Rivers State and shot two of them.

The officers, a police Inspector and Constable whose names were not dis-closed, however died while being rushed to the hospital.

One of the officers who sustained serious gun injuries in the abdomen is still receiving treatment in an undisclosed hospital. The motive behind the attack is yet to be unrav-

The State Police Public Relations Officer, (PPRO), Mr. Ben Ugwuegbulem who confirmed the incident, said the gunmen drove straight to the junction where the officers were working and shot directly at the two officers and fled.

The police spokesman added that investigations over the killing of the police officers was in progress, assuring that the command would certainly uncover the culprits and recover their weapons.

#### Police declare Oyo **NURTW's factional** leaders wanted

THE Police authorities in Oyo State have declared wanted the two factional leaders of the proscribed National Union of Road Transport Workers (NURTW) in the state, Alhaji Abdul Lateef Akinsola (a.k.a. Tokyo ) and Mukaila Lamidi <u>a.</u>k.a. Auxiliary).

Police, Baba Adisa Bolanta who disclosed this at a media briefing said the Command decided to declare them wanted after the expiration of the deadline given the two warring union leaders to report at the com mand headquarters.

Bolanta listed the allegations against the two embattled union leaders as alleged conspiracy, arson, armed robbery and unlawful possession of pro-

hibited firearms. He called on the people of the state to volunteer useful infor-mation that could lead to the arrest and prosecution of the NURTW chiefs while assuring that the identity of such volunteers would be kept secret.

On the claim that the warring NURTW chiefs sent their lawyers to represent them, Bolanta said the police invitation was extended to individuals, adding that the presence of their counsel was not enough to exonerate them, more so, when human lives are involved.

# Ogun now on financial life support, says Amosun

GOVERNOR Ibikunle Amosun of Ogun State yesterday painted a gloomy picture of the financial status of the State and said "Ogun State Government is

Amosun who was in Abuja for the seventh National Assembly inauguration in company former Governor of the State, Chief Segun Osoba added: "In fact, the State could not fund the last May wage bill on its own and had to resort to borrowing from the banks because the State's financial situation is precarious"
"What I met on ground, I

can't explain it. The situation is very bad. In fact, we were not able to pay last month's salaries. We had to resort to bank loans to pay staff salaries. We are going to engage the services of competent independent financial experts to audit the State's finances, because we want to know what went wrong. We would not interfere with their investigations. They will also assist us to totally redesign and re-engineer the

finances of the state."

He continued: "Virtually all sectors of the economy in Ogun State needs to return to its past glory: education, health, agriculture, infrastructure, commerce, just everything is in comatose condition in the state.

'We are embarking on an intervention programme in these five cardinal areas. In the education sector, we are going to make education free-primary and secondary school. And not only that, we intend to provide qualitative education for the people.

Amosun said his government would transform all public hospitals from being mere consulting clinics to standard and efficient health care system.

"We will promote the development of the agricultural sector in such a way that it would nose-dive into major industrial revolution in the state and an avenue for wealth creation in the state."

He also said his administration would generate about 10,000 new jobs within the first 100 days in office to address the crisis of unemployment bedeviling the

Meanwhile, Osoba, has advised President Goodluck Jonathan to be guided by merit and fairness in the composition of his new cabi-

Osoba hailed the emergence of Aminu Tambuwal as the new Speaker of the House of Representatives against the People's Democratic Party's (PDP) South - West candidate, pointing out that the development was a reflection of

true democratic tenets. "We stand for merit, PDP zoning is their headache and if they like, they can go on mourning their defeat, but we in ACN are interested in promoting the tenets of democracy in the country.

"Jonathan is a beneficiary of the principle of merit and democratic norms, so he should stand by his own words and actions and ensure that what he stood for should be allowed to spread to other arms of government," he said.

### feared killed in Akure auto crash

ABOUT 21 persons, compris-ing six male adults, eight women and seven children, were confirmed dead yesterday in an early morning automobile crash, three kilometers from the main gate of the Federal University of Technology, Akure (FUTA).
The accident occurred as the

authorities of the Federal Safety Commission organizing a (FRSC) were workshop at the university for road users on the need to avoid road carnage. Apart from the dead, who had been moved to the morgue of the State Specialist Hospital, Akure, 10 others were taken to the emergency unit of the same hospital with many of

them in critical conditions.

The FRSC said the accident, which occurred around 6.30am at Ilara-Mokin, located on the Ilesa-Benin road, involved a DAF truck with Registration Number LAGOS XU 606 [[] which was travelling to Lagos and a Mazda commercial bus with Registration

Number XV 315 FST belonging to Obadigbo Local Government heading towards Benue State.

The accident was said to have occurred when the truck driver, in an attempt to avoid running into a gaping pothole at his own side of the highway, lost control of the vehicle and ran headlong into the on-coming commercial bus.

Sector Commander FRSC, Ondo State, John Bekinbo Meheux said going by the number of the victims, the bus was overloaded as it showed that it was carrying 28 passengers instead of 15, although the women were said to be carrying their children on their laps.

According to Mehuex, who organized the FUTA workshop for commercial drivers where he highlighted some of the causes of road carnage as mainly over-speeding and impatience on the part of road users, the accident could have been avoided if the drivers of the two vehicles had exercised restraints.

As at yesterday afternoon, the scene of the accident was

besieged by residents of the nearby community particular-ly women who wailed uncontrollably at the site of pools of blood, scattered personal effects of the victims and the twisted metals of the vehicles.

At the State Specialist Hospital, Akure, the accident and emergencies unit was equally besieged by people who were curious about the identities of the victims who were suspected to be mainly of Benue State origin on a trip home from either Lagos or

ABOUT 500 midwives sent to various rural communities across the country, under the Midwives Service Scheme (MSS), yesterday, protested their postings in the light of the April post-election violence in some part of the North which claimed the lives of

some Youth corps members. But, officials of the National Primary Health Care Development Agency (NPHC-DA) assured them of their safety at the various communities of their postings during the

duration of their service.

Meanwhile, patients of the
Federal Medical Centre (FMC)

Gusau of Zamfara State are groaning following their sudden discharge from the hospital as a result of the indefinite strike embarked by workers of the Centre.

The workers are protesting the re-appointment of the Centre's Medical Director,Dr Tajudden Aiyedun.

In his speech, the Executive Director of NPHCDA), Dr. Muhammad Ali Pate said, "today is another landmark development in our nation's efforts to improve coverage of skilled birth attendance in the country."

He pointed out that "another 441 basic midwives who recently graduated from 25 Schools of Midwifery were being enlisted into the Midwifery Service Scheme to further boost the existing number of midwives under the scheme".
