## MOSOP condemns killing of Ogoni youths

THE Movement for the Survival of the Ogoni People (MOSOP) has slammed the Police for allegedly killing two Ogoni youths opposed to a planned relocation of a military cantonment in Zor-Sogho village, Rivers State

MOSOP spokesperson, Bariara Kpalap, said government must respect Article 30 (i) of United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP), "military which states that activities shall not take place in the lands or territories of indigenous peoples, unless justified by a relevant public interest or otherwise freely agreed with or requested by the indigenous peoples con-

Kpalap, who accused the Police of shooting Mr. Goteh Keenam and Mr. Dambani to death, said the incident engendered a provoked spontaneous reaction that culminated in the lynching of Mr.

We have heard from all of the village witnesses that the suspected youths for which the police came did not resist arrest and there was no immediate threat to the safety of any of the mobile policemen. The interviews showed clearly that the murdered youths were shot dead without any good reason

Job Nkpai, who allegedly invited the policemen.

He explained that some chiefs and elites in the village were accused of promoting the planned sale of a large parcel of their farmlands for military cantonment relocation project without the "free, prior and informed consent of the people." Kpalap said about two weeks ago, the villagers had spotted surveyors attempting to survey the controversial farmlands without any consultation and approval of the people and stopped the job. Afterwards, a communal meeting was conveyed and the people flayed some chiefs and other community leaders, including Nkpai, who they accused of compromising.

Nkpai was alleged to have reported to the police, "albeit spuriously," that his life was being threatened by some youths in Zor-Sogho who were opposed to the planned military base.

And based on this, some mobile policemen were deployed to the village to effect the arrest of those who Nkpai allegedly threatened his life over the disputed project. According to Kpalap, it was in the bid to effect the forceful arrest that the police shot dead Messrs. Keenam and Dambani.

Kpalap added: "We have heard from all of the village witnesses that the suspected youths for which the police came did not resist arrest and there was no immediate threat to the safety of any of the mobile policemen. The interviews showed clearly that the murdered youths were shot dead without any good reason."

But when contacted at about 2:01p.m. the Police Public Relations Officer, Ben Ugwegbulam, told *The Guardian* that he was still trying to gather facts surrounding the incident and that he would call back.
