Mob burns suspected armed robbers in Ibadan, Akwa Ibom

Mob on Wednesday set a suspected armed robber ablaze in Ibadan, the Ovo State capital.

The suspect and a member of his syndicate were said to have been involved in an accident at the state secretariat, Agodi, with the other suspect giving up the ghost immediately.

The mob pounced on the two suspected persons after they lost control of the motorcycle they rode while making away with a phone and other valuables robbed from one Adebayo Tobi.

Upon being robbed at Favos area of Bodija, Adebayo Tobi, with his car, gave the robbers a hot chase until they entered a pothole, lost control of the bike and fell off opposite the state office of the Independent National Electoral Commission (INEC) on the State Secretariat-Mokola road.

While one of the robbers died on the spot as a result of the crash, the other who with clubs and other weapons until he died and was then set ablaze. His body was up in flames while the other was left lifeless. Men of the state joint security task force, known as Operation Burst and the Nigerian Police Force were later sighted at the scene. The state Police Public Re-

lations Officer, Mr Gbenga Fadevi, said efforts were on to investigate the incident.

A statement made available to journalists read in parts: "Incident of robbery/fatal motorcycle accident on December 16. Around 3:30p.m., one Adebayo Tobi, aged 27, of Plot 4, Owode Apata, Ibadan, was robbed at Favours area. It was gathered that the suspect was caught while trying to snatch an android phone from another person and an alarm was raised and he was immediately set ablaze.

An eyewitness, Ben Akpanette, told newsmen who visited the scene that the suspect was notorious for snatching phones and dispossessing others of their belongings around plaza axis and Abak road, adding that he met his Waterloo Wednesday night when he attempted to commit the crime at the adjoining

According to him, "his cup was full last night when he was caught trying to snatch phone from somebody. People raised the alarm and he was

caught then burnt to charcoal. He belonged to the gang of criminals that normally attack innocent members of the public at the plaza, Abak road and NEPA line area within Uyo, but last night, God allowed bad people like him to deal with him there."

When contacted, the Police Public Relations Officer in the State, SP Macdon. said he would react when he gets brief on the incident.
