## Soldiers Burn 100 Houses In Port Harcourt

•Militants Kidnap Two Oil Workers, Kill Soldiers •SSS Smashes Syndicate In Delta

By Odudu Okpongete, Port Harcourt and Tunke-Aye Bisina, Asaba

Soldiers have burnt down at least 100 houses around the premises of Italian oil company, Saipem, where at least one Italian worker was kidnapped and his bodyguard killed overnight.

Residents said the soldiers stormed the waterside settlement around the compound of Saipern, a unit of Italian oil giant, ENI, poured petrol over the houses and set them on fire.

At least two people, including one Italian oil worker, were kidnapped from a bar in the slum area on Thursday night. The gunmen, who took them hostage, also shot and killed an army sergeant, who was protecting them

Families returned to the area around the Saipern compound on

Friday morning, searching the ruins of their houses to recover personal items, but were chased away by soldiers brandishing bottles and throwing stones.

The reprisal came after
President Olusegun Obasanjo
ordered the security services to
use "force for force" against
militants, who have staged eight
separate abductions this month
alone.

In total, at least 19 people have been kidnapped, but only three are still in captivity.

The Rivers State government has been encouraging this by promptly paying large sums for their (hostages') release," said the militant Movement for the Emancipation of the Niger Delta, MEND, which has taken hostages but said it was opposed to kidnapping for ransom.

One attempted hostage release went wrong last Sunday, when militants bringing a Nigerian employee of Royal

and soldiers, which lasted for

The surprise attack reportedly left two persons dead, including a soldier, who was apparently guarding the expatriates

working for an Italian oil servicing firm, Saipem Nigeria

However, about six persons

reportedly received serious injuries during the attack, although it was not immediately clear whether the injured

persons were mostly soldiers. Sources around Aker Base told our correspondent that the militants entered the base

disguised in military uniform and immediately moved to abduct the expatriates but faced serious resistance from a soldier who was guarding the base.

The attackers, who reportedly came through a waterfront in the area, entered a drinking joint known as Carol Bar within the

base, where the expatriates were drinking and chatting. The militants then dragged the expatriates out.

The action of the suspected militants reportedly angered the

soldier, who protested immediately but was silenced by bullets aimed at his head while another who dared them was shot in the leg.
The attackers, sources said,

disappeared immediately with the kidnapped expatriates before the arrival of a batch of soldiers from the 2 Amphibious Brigades, Port Harcourt

The soldiers reportedly set the houses ablaze based on claims that the residents of the slum

area around the Aker Base were harbouring the militants that unleashed the attack and abducted the expatriates. When our correspondent visited the area Friday afternoon, the rubbles of the burnt

buildings which accommodated hundreds of people were covered in

heavy black smoke. One of the affected residents, who spoke on condition of anonymity, said the belongings burnt by the

rampaging soldiers run into several millions of naira. Although, a security man at Saipern claimed the foreign oil workers were returning off-shore.

Officials of the company, however, refused to speak on the incident But spokesman of the 2 Amphibious Brigade in Port Harcourt, Major Sagir Musa, confirmed the incident.

He explained that the soldiers were caught unawares as a result of the camouflage worn by the militants. He said when the assailants first entered the base, the soldiers on

duty mistook them for friends because of the way they were dressed, but madé a late resistance when the militants started shooting and seized one of the white men Major Sagir could, however, not
