Police Kill Three Armed Robbers In Asaba

Asaba, the Delta State capital, was virtually turned into a theater of war at the weekend when a daredevil armed robbery gang that had terrorised residents engaged policemen in a gun duel, which left three of the bandits dead with the policemen sustaining serious inju-

The gang was said to have attacked a filling station along the Okpanam Road at 5.50 p.m. on Saturday and made away with about N220,000 before they engaged the policemen who were on their trail around the Ibusa Junction.

The robbers shot two policemen who tried engaging them during the operation resulting to serious injuries on the officers.

Eve witnesses told Daily Independent that after the operation at the filling station, the robbers abandoned the Audi 80 car with registration number CM 396 they drove to the scene and hijacked another Toyota Land Cruiser Jeep with registration number BN 250 ABC.



Five Persons Slump At Lagos PDP Rally

No fewer than five persons, including two policemen on Saturday in Lagos slumped at the Presidential campaign rally of the Peoples Democratic Party (PDP) candidates for the April general elections, Umar Musa Yar Adua and Ionathan Goodluck.

But Lagos Police Public Relations Officer (PPRO), Bode Ojajuni, said in a telephone interview that

such incident is common in the kind of crowd that gathered at the Tafawa Balewa Square on Saturday. He, however, said no life was lost at the rally.

A competent police source said the two policemen slumped as a result of exhaustion, adding:. "There was no water, no food for people that left home the previous day and were on stand-by till around 12 noon on Saturday when the rally actually kicked off:"

He said apart from the few inci-

dences of phone theft and vandalised cars, every other thing was under control by the over 300 policemen detailed to ensure security in and around the venue of the event. The source added that at least 36 cases of GSM handsets theft was reported and recorded by the Police at the rally.

"Apart from the policemen, three other persons also collapsed during the rally and were resuscitated by members of the Red Cross Society at the venue," he said.

Hell was let loose on Sunday around the Township area of Port Harcourt, the Rivers State capital, from the Lagos Bus Stop to the Abuja Estate, towards Borikiri as cult members loyal to Soboma George, a renowned cult leader, went on rampage.

By the time the dust settled, they had burnt down several cars around the Central Police Station in protest over George's arrest earlier in the day.

The incident caught those returning from Church unawares, as they had to scurry for safety, while shops that opened for business and the NNPC Mega Station in the area had to hurriedly close down.

This, according to sources has attracted the anger of the boys said to be his (George's) ardent followers. It was gathered that the boys have vowed to vent their anger through killer weapons, until George is unconditionally released with immediate effect.

Two Die In Zaria **Auto Crash**

The luxury bus with registration number SD 951 NEN was traveling from Lagos to Kano when the accident occurred.

There is apprehension that more victims may loose their lives as many were seriously injured, with severe fractures.

Daily Independent gathered that the luxury bus ran into an abandoned véhicle when the driver swerved off from the road.

Management of the Kano branch of the Young Shall Grow Motors dispatched some of its staff to the accident scene to help move victims out of the scene.

Strike Grounds British Airways

After talks with its largest union collapsed, British Airways has can-celled about 1,300 flights to different destinations this week.

The flight cancellations would affect no fewer than 140,000 passengers and involve most flights to and from London's Heathrow and Gatwick airports, with further disruption before and afterwards.

The Transport and General Workers Union (T&G) had threatened two additional 72- hour strikes in February unless there was agreement on issues which include sick-leave policy and pay.

About 96 per cent of the cabin crew represented by the union is in favour of strikes,

At the Nigerian end, British Airways has apologised to its customers for the inconveniences caused by the strike. In newspaper advertisements on Sunday, the airline confirmed that its operations would be reduced in all its networks due to industrial action.

"As a result of this action, British Airways will be operating very limited schedule between January 30 and February 16," the advertisement read.
