Witnesses alleged that <u>PDP</u> supporters armed with guns and cutlasses descended on members of LP at the Moniya venue of the rallies on Tuesday and five persons allegedly lost their lives.

Ngige, Etiaba, Others Protest Plot To Rig Guber Polls

Eleven governorship candidates on Tuesday protested alleged plot by the police, Independent National Electoral Commission (INEC) and the Peoples Democratic Party (PDP) to rig the polls in Anambra State.

The protesters were Dr Chris Ngige of the Action Congress (AC). Prince Nicholas (AC), Prince Nicholas Ukachukwu of the All Nigeria Peoples Party (ANPP), Dame Virgy Etiaba of the All Progressives Grand Alliance (APGA), Mr Alex Obiogbolu of African Political System (APS), and Mrs Njideka Anyadike of the African Democratic Congress (ADC).

Others included Prince Osita Ezenwa of the Democratic Peoples Party (DPP), Arthur Nwandu of Peoples Mandate Party (PMP), Chief Uche Onyebuchi of the Labour Party (LP), and Emeka Okafor of (LP), and Emeka Okafor of Peoples Progressive Alliance

The candidates marched to the state headquarters of INEC and the state Police Command, Amawbia, where they held a meeting with the Deputy Po-lice Commissioner, Mr Amusa Bello. The meeting lasted about an hour.

When the candidates attempted to speak with reporters, police officers at the command refused, saying they were not allowed to grant in-

terviews within their premises. They, however, later met elsewhere and mandated Obiogbolu, Anyadike, and Ezenwa to speak to reporters.

Obiogbolu denied stories that the candidates have agreed on a consensus candidate to confront PDP. He said their alliance was aimed at ensuring that the polls are not

rigged. In two letters to the Inspector General of Police, Sunday Ehindero, and INEC Chair-man, Prof. Maurice Iwu, the candidates accused the police and the commission of working to rig the elections.

According to the Chairman, Caretaker Committee of Akinyele Council, Solomon Adeniran, the party was waiting for the arrival of invited guests when the incident happened: "We were to have a campaign at Moniya Roundabout waiting for some prominent members of the party to come and mount the podium. We were sing-ing and dancing. Suddenly, some hoodlums loaded in a trailer ar-rived the scene, brandishing dangerous weapons."

He added that the hoodlums barricaded all the roads leading to Moniya to prevent any intrusion.

"I just received a phone call now that I should not come to Moniya where the headquarters of my lo-cal government is," the chairman

A member of the caretaker committee, Joshua Oyebanji, confirmed the casualty figure. He said the at-tackers wore T-shirt with the in-scription of PDP. He added that he had reported the case to the police

Similarly, at Oke-Ado, a group of armed thugs also pounced on Labour Party supporters. They

killed two people.

Eyewitness said thugs arrived the scene of the rally shooting indiscriminately at the people and attacking them with cutlasses.

An LP membersaid two of their supporters were shot dead while 20 were injured.

He said most of the victims were armless people who were just at the rally to hear what their candidate had to say.

But the state Secretary of the PDP, Alhaji Tunde Olayiwola, dismissed

the allegation that some of their supporters carried out the attack.

He added that they were somewhere else holding campaign when the incident occurred.

"Though I have not got the details of what happened, I am sure that our supporters are law-abid-ing people who would not do such a thing," he said.

The state Deputy Commissioner of Police, Olatunji Caulcrick, and Public Relations Officer, Olu Akinmoladun, confirmed the incident. But Caulcrick said he only knew that three people died.

"We are going to make some ar-rest soon," he promised:

Six Kano ANPP **Supporters Die** In Auto-crash

Six members of the All Nigeria Peoples Party (ANPP) died in a motor accident involving the campaign train of Kano State Governor brahim Shekarau.

The incident occurred during Easter when the governor's campaign team was going to Wudil local government for a rally.

The identities of the victims could

not be ascertained as at press time but witnesses said one of the buses conveying party members and sup-porters somersaulted after veering off the mad.

They disclosed that the six people died on the spot while several others were rushed to the Wudil General Hospital.

Government House sources said Shekarau decided to put off his campaign, which was billed for Monday and Tuesday, as a mark of respect for the departed party mem-

The governor confirmed in an interview with journalists that some of his supporters died in the accident. He said the party was in mourning and as such could not continue the campaign.

He prayed for the repose of the souls of the deceased who have been buried according to Islamic

Meanwhile, non-indigenes have been moving out of Kano State ahead of the Saturday elections.

They are fleeing the state for fear that the elections may not be vio-

Police Arrest 12 AC Leaders In Lagos

Police in Lagos have intensified their clampdown on the Action Congress (AC) ahead the Saturday governorship and state assembly elections.

On Monday evening, the police arrested 12 chieftains of the

Sources said the AC members have been sent to different parts of the country, obviously to get them out of circulation during

the elections. But the state Police Public Relations Officer, Olubode Ojajuni,

denied the arrest. This development is, however, coming at a time the Secretary of the party in Lagos, Joe Igbokwe, alleged that the Peoples Democratic Party (PDP) had deployed a naval team and 10 police commanders to help in its bid to rig the elections in the state.

He levelled the allegation in a statement on Tuesday.

He said the PDP targeted riverine communities and some designated constituencies for the deployment of the naval and police personnel.

He stated that a few days ago, a naval team from Bayelsa State and 10 police commanders were deployed to the state under the guise of providing security during the elections.

Igbokwe said the aim of the deployment is to ensure massive rig-

ging in seven riverine communities, which he said from record barely witness election-related violence to warrant such deployment.

Among those arrested, according to sources, are Taiwo Folami who was taken to Kano and Semilat Dosunmu.

Igbokwe added that 20 top police officers have also been brought into the state and are being trained in Alimosho Council to perfect the art of changing ballot boxes

He said each of the police commanders would be assisted by 100 policemen "who are currently undergoing drilling at a location around the state to make their assignment easy and thorough".
