It was found out that as at 2,30pm, no vote had been cast at

the voting unit.

A check at the voters' register showed that no fewer than 259 names were listed there.

It was gathered that following the strange development, some officials of the Independent National Electoral Commission (INEC) had to go from house to house to persuade the residents to come out and vote.

#### **DPA House Of** Assembly Candidate Arrested With Ballot Boxes

A House of Assembly candidate on the platform of the Democratic Party Alliance (DPA) in Lagos State, (names withheld), was on Saturday arrested by security operatives with ballot boxes allegedly stuffed with

The candidate, according security sources, was accosted by military men along the Nigerian National Petroleum Company (NNPC) road in Ejigbo area of Lagos with a van and the ballot

The Special Adviser/Permanent Secretary, Ministry of Information, Lagos, Segun Ayobodu, confirmed knowledge of the incident, claiming that the suspect has been taken away by security personnel.

Also at Ipaja area of Lagos in

Alimosho Local Government, a ballot box was stolen by unidentified persons, while in Ikoyi, some people were allegedly prevented from voting.

No reason was given for this action by Independent National Electoral Commission (INEC) official at the affected centre when confronted.

Meanwhile, voting was peaceful in Ikeja area and it started early.

#### **Absence Of My** Picture On Ballot Paper Deliberate, Says Agbaje



Democratic Peoples Alliance (DPA) governorship candidate for Lagos State, Jimi Agbaje, whose picture was absent from the independent National Electoral Commission (INEC's) ballot paper at the polling booth on Saturday has described the omission as "a high level of negligence" on the part of the electoral umpire.

Agbaje, voting at his Apapa residence, described the omission

as unfair and a disappointment. "When I got to the polling station this morning at 10.30am to cast my vote, I found out that my picture was not on the ballot box. This is very unfair and insensitive of INEC. When INEC asked for photographs, they were sent; and if INEC discovered that they did not have the picture, they should have made a request for another," Agbaje said.

He added that INEC did not create a level playing ground in the electoral confest.

Areas engulfed by fracas in Ogun State include Abeokuta South Local Government area, Ijebu-Igbo, Ijebu-Ode, Ifo, Sango-

Ota and Shagamu. Asearly as 7.00a.mat ljemo, Ago-Oko and Ake areas of Abeokuta South Local Government, suspected thugs led by a chieftain of the Peoples Democratic Party (PDP) took over the entire vicinity and unleashed may hem on people believed to be their political

While elections began at about 10.30am in most of the 510 polling booths of the Oshodi/Isolo council area in a generally peaceful atmosphere, there were pockets of clashes among members of the AC and those of the People's Democratic Party (PDP) at places such as Mafoluku, Shogunle and Brown Street.

Our reporter witnessed, at Oshodi Motor Park, a team of mobile policemen in mufti and a convoy of three vehicles allegedly from the SCID, Panti Street, and led by a PDP House of Representatives candidate, and his wife (names withheld).

The team reportedly arrested some men believed to be AC loyalists and were taken to an unknown destination.

#### **INEC Didn't Create Level Playing Field**

A vehicle marked FG 499-V01 conveying sensitive voting materials was on Saturday morning attacked by three unknown gunmen, according to a driver, Samson Okone.

Okone, a senior driver with the Independent National Electoral Commission (INEC) said the attack took place at Shagamu, Ogun State. The vehicle was enroute Lagos from Abuja.

"We ran in to the ambush at about 1.00am", Okone explained, saying the three armed men, suspected to be armed robbers, "opened fire at . us but I was able to dodge the bullet alongside the police escort and another INEC officials".

He said the escort then gunned down one of the assailants, while the others fled, leaving the . windscreen of the vehicle ". shattered.

"From what I have seen today, I am happy about the whole voting process. The atmosphere has been very peaceful and I believe that it will disappoint some of our rivals because they had gone to town claiming that the PDP was planning to unleash violence on the

"I have information that the AC is busy rigging to win. For example, non-residential areas such as Alausa, where there is virtually little or no concentration of people is one of such areas being used to

manipulate votes," he claimed. Voting began around 8.45am at the centre with verification of voters amidst fears of possible attack or disruption of the exercise by hoodlums. Around Adeniji Adele and

Apongbon there were different contingents of armed soldiers and the streets were littered with broken bottles. But voters at the various

polling booths in Lagos Island, just after Obanikoro cast his vote around mid-day, said that the voting has been entirely free of

# Tinubu Votes, Happy With Polls

Lagos State governor, Ahmed Bola Tinubu, on Staurday cast his vote at noon at the Alausa voting centre in Ikeja, Lagos, where he described the conduct of the election so far as peaceful and orderly.

The governor, who arrived the voting centre at 12.20p.m. with his wife, Oluremi, and other security aids, had asked the Independent National Electoral Commission (INEC) official at the centre to search out for his name as he was not with his card because the card is with his police Aid-De-Camp (ADC) who has been whisked away to Abuja on the orders of the Inspector General of Police (IGP), Sunday Ehindero. The INEC official accordingly checked out and found Tinubu's

name and thereafter gave him the voting cards.

After casting their votes Tinubu and his wife proceeded to see his mother, Alhaja Habibat Mogaji, who had earlier voted in

the morning.
Speaking with newsmen at his mother's residence, the governor said that information reaching him indicated that there were some hiccups in the conduct of

Tinubu blamed the hiccups on inadequate preparations by the

He said voting did not start early at the river-rine arrears of the state as INEC officials were not available on time to enable people cast their vote there.

In FESTAC town, the logo of Peoples Democratic Party (PDP) was missing in the voting

"INEC is aware of this election, they have three and half years to prepare, but this is what we get. If the election was designed

to fail we will know later tonight, but things are not what we expect", Tinubu said.
On the heavy presence of the military, especially in Lagos, Tinubu said he did not mind as

long as the military went about their duty peacefully, adding though that this is unusual in a democratic setting.
"It is part of the unpreparedness of the INEC.

Election is a civil matter and police is best suitable for that but we have to take it, military men are not our enemy, if we do not have enough police they can come in," he said.
