administration is labourintensive, the FIRS staff have been undergoing constant training and retraining, stating that as an apostle of the Federal Government's reform agenda, the FIRS commenced the initiative for the first time in its history and as a deterrence to tax evasion.

In his speech, controller of the Sapele Integrated Tax Office, Mr Nicholas Obiajunwa, explained that current reform programme of the Federal Government also affected the tax administration of the government.

He pointed out that despite the benefits of the tax collected to the public, the FIRS still finds it difficult for some key beneficiaries to comply with provisions of the tax law.

Obiajunwa appealed to chairman of the Sapele Council to assist the FIRS spread the news of the establishment of the Integrated Tax Offic (ITO) to the various contractors, restaurants, supermarkets, cyber cafés, and other taxable persons and organisations for them to render their monthly VAT returns, annual companies income tax returns, withholding taxes, VAT registration and obtaining of tax clearance certificates.

## One Killed, Houses Destroyed In Ogoni Cult Clash

A member of the notorious De-Gbam cult group in Rivers State, whose name was given as Sunu-Omue Suanu, was reportedly killed in a fatal clash with a rival group, De-Well, in Kpong, an Ogoni community in the Nyokana district of Khana Local Government Area of the state.

The clash also left several members of both groups injured and no fewer than six houses destroyed, including the shrine of the Ateeh deity.

We gathered that trouble started when one Mr Dormu. an indigene of Kpong, invited the police to arrest the Ateeh and Taa chief priests, claiming that they destroyed his property.

Sources said after their arrest and subsequent release, Dormu reportedly discovered that the chief priests were members of the Dewell cult group, who defected to De-Gbam after offending their former members, and sought the protection of the leader, one Yiinu Sergeant aka Umaru Dikko.

We also learnt that because the community's paramount ruler's interest in the De-Well group, he succeeded in sending Sergeant and few of his men on exile.

But while in exile, Sergeant was said to have mobilised and got support from neighbouring communities of Beeri, Zaakpon, Okwali and others and launched a reprisal attack on Kpong community.

According to sources, after the clash, several groups were said to have intervened to ensure calm returned, notable among which is the Academic Associates PeaceWorks (AAPW) in Bori.

The group's Project Officer, Mr Lucky Duumaa, said the community's elite had met with both parties and that those concerned have agreed to sheathe their swords.

He, however, lamented that lack of funds was hampering the arrangement to cater for the displaced members of the community and called on the state government to intervene.

Speaking on the matter, one Linus Kpabari, a community leader, appealed to the elite in the community to see the crisis as a challenge and find a way of resolving it amicably.

He also commended the effort of the AAPW for its interest in finding a solution to the crisis.

Warri zonal council of the National Union of Petroleum and Natural Gas Workers (NUPENG) has threatened to embark on industrial action this week if Chevron Nigeria Limited (CNL) does not meet its demand for harmonisation of the pay structure of all its contract workers.

Other decisions taken at the end of the union's meeting in

Warri include harmonising the lingering Collective Bargaining Agreement (CBA) negotiation of Joceco and Pat Onosen with the CBA of other contract group.

The communiqué, which was signed by Comrade John (National Vice President), Comrade Williams Akporeha (Zonal Chairman), Comrade Bernard Ugbi (Assistant General Secretary) and Comrade Edmond Ofudie (Zonal Secretary), also said that

the management of Polmaz other authorities concerned should recognise the workers already granted recognition by NUPENG and that their salaries be paid before the end of every month.

expended bullet shell at the scene.

The command also disclosed that another robbery suspect was arrested along the Aba-Port Harcourt expressway after his gang's gun duel with a police team on surveillance. The suspect's Amos, 23 years, and a male.

It said one locally made

revolver, three live 9mm ammunition and one Olink 150 model motorcycle with registration number BY 3405B were recovered from the gang.

The force a cultist, named Frank Ogbomuna, was arrested at Timber Street, Mile I, Diobu, as well as another name was given as Ubong Inye Amachree (male), associated with the De-Well cult group.
