Gunmen Kill Agagu's Ex-<u>CSO</u>

Fear on Wednesday gripped the security personnel of Ondo Governor, Olusegun Agagu, after his former Chief Security Officer, Tunde Awanebi, was murdered a few hours after he was sacked.

Awanebi, a retired Assistant In-

Awanebi, a retired Assistant Inspector General of Police, was shot in the head in a pharmaceutical store on Ijoka Road, Akure

about 9:30 p.m.

Eyewitnesses said the assassins trailed him on a motor cycle to the store where he had gone to buy

some medications.

They ordered everyone to lie face down. One moved close to Awanebi and shot him severally in the head. The killers left off before anybody could raise an alarm.

The owner of the store rushed Awanebi to the State Specialist Hospital, Akure, where doctors

certified him dead.

Police Commissioner, Innocent Ilozuoke, confirmed the incident and said the police have placed a machinery in motion to arrest the killers.

On Tuesday night, a member of People Democratic Party (PDP), Bode Alonge, was murdered in

which the deceased was an ac-

tive participant. "How come that the very day on which (Awanebi) was sacked was the day he was shot dead? Who wanted him dead but those who felt that he might spill the beans (after) he had been unceremoniously eased out after being used for their dirty job? These are questions the PDP must answer instead of pointing accusing fingers at the wrong direction," Olabisi charged. Meanwhile, Agagu has

of the state execute council and approved the appointment of Deurimini Isaac Kekemeke as the Secretary to the State Government. Kekemeke was Commissioner for Works, Lands, and Housing; and had served as Attorney General and Com-

missioner for Justice. Before all that, he was Minority Leader in the state Assembly between 1992 and 1993. A statement issued on

Wednesday by Agagu's Chief Press Secretary, Yemi Olowolabi, thanked the commissioners and special advisers for their service to the people and wished them well in their future endeavours.
