At least five people were kill

in Port Harcourt, the Rivers St.

At least five people were killed in Port Harcourt, the Rivers State capital, on Monday when two rival cult groups clashed in the Rumuolumeni area of the metropolis.

Members of the community immediately vacated the area to avoid being attacked by the warring factions or indiscriminate police arrest in connection with the killings.

But the police claimed that only

two people were killed and six others received bullet wounds when the hoodlums clashed in the early hours of the day before the law enforcement agents got to the scene.

Eyewitnesses said trouble started on Sunday when some cult members loyal to one of the factions in the community accused the youth leader of the area of belonging to a notorious gang in the state. They asked the leader and his supporters to leave the community.

When the youth leader identified as Golden Isi resisted their assault
