## Awolowo's Disciples Were 🦩 Like Tesus' – Clergy

Vicar of Our Saviour's Anglican Church, Venerable Foluso Babatunji, has lamented that the ideals and policies of the late sage, Obafemi Awolowo, were misconceived by many Nigerians.

He stated this at Efunyela Hall, venue of the posthumous 99th Birthday of Awolowo that his policies and ideas were not respected while alive, but is now celebrated."

Born March 6 1909, the sage died in 1987. Ikenne, the ancestral home of the Awolowos stood still, as the Ogun State Governor, Gbenga Daniel, played host to prominent Nigerians from all walks of life.

The cleric also likened some of Awolowo's disciples to Jesus Christ's disciples, because they failed to have faith in the programmes and ideals of their leader, as was done to Jesus Christ

"If we did not believe in the original Awolowo by misjudging him and his ideas, then there is need for us to believe in the present day Awolowos in positions of authority. It is pertinent that we believe in ourselves," he added.

Babatunji noted that many people misunderstood the sage while alive, describing him as a" true statesman and civil servant. During his time, Papa Awolowo was a phenomena genius and a bright star which his generation did not celebrate, until after his death." The cleric further said that the

invaluable contributions of Papa Awolowo to the nation would remain entrenched in the history of the nation, saying, "Always see something good in people around you. It is good to criticise but always make it constructive."

## I Am Confident Of Victory At Appeal Court, Says Orji

Former Governor of Abia State, Theodore Orji, on Friday declared he is confident he will floor his opponent, Onyema Ugochukwu, at the Appeal Court. He spoke to reporters at the Murtala Muhammed

International Airport, Lagos. Orji was removed by the Tribunal sitting in the state last month, when it declared that he (Orji) did not resign as Chief of Army Staff to the former Governor of the state, and that he belonged to a secret so-

Orji, however, told journalists in Lagos that he has proof of his resignation and is ready to present it in

"If I don't have confidence, I will not go there. I will have victory because I have the facts. Don't mind what the Peoples Democratic Party is saying, because if you go through the judgment, they said I did not re-

"Having been a Permanent Secretary for many years, I had also worked with the Independent National Electoral Commission (INEC), so I know the implication of non-resignation. I did resign at

the appropriate time. And they were saying I took salary in April. In April, I was in detention, do you take salary when you are in detention. They never tendered any document to show that I received my salary. "They also said that I am a member of a secret cult. In the first instance, that thing they are mentioning is a shrine and I don't know anything about that shrine. They claimed I am a member and they have to prove it. The man who came to Court is a hired man, and he was not even listed and PDP did not take the leave of the court to list the man as a witness." he said.
