Pandemonium broke out in Lagos at the weekend when a street beggar stabbed a fellow beggar with knife over a disputed N20 note.

Trouble was said to have broken out on Sunday at about 12.10 p.m. when one of the beggars, Abdullahi, claimed that the N20 note dropped by a motorist driving past on Mile 12, Ketu, flyover belonged to

Following a heated argument and irked by the refusal to release the money to him, it was gathered, Abdullahi pulled out a knife from his waist and stabbed his colleague in the chest who gave up the ghost on the spot.

He said the suspect was arrested by his colleagues before he was handed over to the operatives at Mile 12 Police Post, Ketu.

Mba said the murder suspect has been transferred to the homicide section of the State Criminal Investigation Department (SCID), Panti Street, Yaba, Lagos, for further investi-

According to him, the corpse had been removed and deposited at an undisclosed mortuary in Lagos for autopsy.

"They were two and one of them stopped at Mile 2 Bus Stop while the other was going to

Wharf. He has been shouting for his balance of N750.00 but there was no response from the conductoruntil when we got to Liverpool Bus Stop.

A police Inspector, Magnus Nweke, attached to the Apapa Police Division who led a team to the scene of the incident confirmed that the corpse of the victim had

been deposited at the Lagos Island General Hospital, while the suspect is under police custody at the Apapa Police Station.

He said from what the driver of the bus told him, the victim and the

conductor were in a hot argument about money.

You know I am on the wheel here and there is no willy I would be able to know what is going on behind. It is when I stopped the vehicle that I saw the passenger with blood; they say my conductor used wheel spanner to hit the passenger on the head."

Police gave the name of the driver as Madu Magnus and the conductor as Charles.

Passport Forgery: Court Hears.— Suspects' Bail Application Today

A Federal High Court sitting in Lagos will today entertain the bail application of four persons standing trial for alleged passport forg-

The accused persons include Joseph Chinekezie, Obinna Ijezie Okuwonu, Patrick Aioukhai and Ogabi Okanlanwon.

The Nigeria Immigration Services arrested them on January 22, 2009, at the Mohammed Murtala International Airport, Lagos, for allegedly carrying fake electronic passports.

Okuwonu, Aioukhai and Okanlanwon were later arraigned before Justice Pat Ajoku while Chinekezie was arraigned before Justice Mohammed Sanni.

They all pleaded not guilty to the charges preferred against them after which they were remanded in Ikoyi Prison.

According to the Assistant Legal Adviser of Immigration, Abuja headquarters, David Babale, Chinekezie, who was traveling to Italy, said it was one Aioukhai, a tout at Ikeja, whom he gave some money to help him obtain the pass-port while Patrick also claimed that Okanlanwon got the passport for him at Oluwole.

On the other hand, Babale narrated that Okuwonu traveled to Senegal without a passport but was arrested at the Murtalata airport while coming back with a forged passport.

Anybody that is in possession

of a fake or forged passport is guilty of an offence and that is why we charged them to court," he said.

He added that forgery of the Nigeriampassport is a serious offence. He advised Nigerians not to get their passports through proxy but go through the immigration of-fices.

"You can get your-passport within two or three days; it does

not take a long process.

"Forgery of government document is a very serious offence. People don't know and that is why-

they keep forging our passport.
The punishment is life imprisonment. So we want Nigerians to know that it is a serious offence for anyone to tamper with any document that belongs to the federal, government," he said.
