Pregnant Woman, Son, Maid Found Dead In Enugu

TRAGEDY struck in Enugu on Wednesday when a pregnant woman, her son and housemaid were found dead in their apartment.

The woman, identified as Amauche Onyia, a native of Agbudu in Enugu State, was until her death a provision dealer at

Amauche, her son and house-

maid, were suspected to have been choked to death by smoke inside their apartment at 14 Neni Street, New Layout, Enugu.

Sources said that the incident occurred when the upholstery in the apartment was inflamed by a burning candle in the sitting room while the woman and members of her family were asleep.

The smoke reportedly choked them to death in their sleep.

Neighbours said that they noticed the smoke in the morning

and started knocking on the door of the two-room apartment but no-body responded.

They were forced to break into the apartment, where they found Amauche, her son and housemaid lifeless:

The discovery caused a stir in the area as neighbours of the victims wailed while sympathisers thronged the apartment on hearing of the tragedy.

A resident of the area told our reporter that the husband of the

deceased, who was identified as Sunday, was not at home when

the incident occurred.

The source disclosed that the husband spends the nights outside his home most times because of

the nature of his work.

When contacted on phone, PolicePublicRelationsOfficer(PPRO) in Enugu, Ebere Amaraizu, said

that he was in Abuja.

Meanwhile, the bodies of the victims had been taken away by policemen.
