## Missing Boko Haram inmates: Cou summons Borno Prison boss •Gunmen kill top civil servant, two others in Maiduguri

THE SPATE of killings in the

northern part of the country

continued on Wednesday night

as a Director in the Borno State

Civil Service and two others were mowed down in Maidu-

guri, the State capital, by gun-men suspected to be members of the Boko Haram sect.

Two other persons were se-

riously wounded in the attack

by the men, who reportedly trekked to the Director's house,

wearing flowing gowns. This

is the latest in a wave of attacks that have led to the killing of more than 15 persons since the end of the Muslim holy month

of Ramadan. It happened just as the state judiciary is taking on officials of the Nigeria Prison Service (NPS) over the disappearance of 24 suspected Boko Haram inmates who were in custody in

who confirmed the latest killings, named the victims as Turmda Malgwi, the Director, and Yakubu Iliya, a 67-year-old retired civil servant. The third person, in his early 20s, could not be identified. Although the police confirmed receiving a report of the killing at about 10.35 p.m. on Wednesday, Daily Independent gathered that the bodies of the deceased were not discovered until the following morning as residents of Bulumkutu suburb, where they were attacked,

remained indoors out of fear. According to a witness, the killers arrived the director's house on foot and suddenly opened fire on him and two others who were relaxing in front of the house shortly after the late evening prayers. The killers left immediately after the shooting.
Illiya and his two friends

died instantly. Two others were said to have been wounded by stray bullets.

Midenda explained: "I received the report of the attack and killings in Bulumkutu at about 10.35 p.m. from one of our men in the field, stating that three unknown gunmen
