Man murders 10-yr-old girl in Mando

•Removes private part for ritual

The residents of Mando, a suburb in Kaduna metropolis, are grieving over the death of a 10-year-old girl, Hussaina, who was allegedly murdered by a resident of the area, one Musa, 28.

Musa had allegedly used a sharp knife to remove the private part of the girl, which led to her death.

An eyewitness, Bala, said Musa who is a neighbour and a relation of the murdered girl, met the deceased in their house in Mando and demanded that she assist him with food, even if it is a leftover since he was very hungry. The eyewitness revealed that Musa directed the deceased to meet him at a corner with the food which she agreed but on getting there with the food, Musa allegedly grabbed her neck and as soon as she became unconscious, he reportedly used a sharp knife to remove her private part.

The suspect was said to have attempted to flee the scene after he committed the heinous crime but was said to have been accosted by passersby who attracted the

attention of people in the area who wanted to carry out jungle justice on him but for the early intervention of elderly people in the area who advised that he should be handed over to the police. The witness further explained that when tortured to name his sponsors, Musa who explained that he perpetrated the crime due to abject poverty, disclosed that he approached a friend a.k.a Ataka who allegedly linked him up with one Alhaji Yahaya, also a resident of Mando. According to Musa, they met with the said Alhaji Yahaya in his office and he agreed to assist him financially if only he could provide him with the private part of a virgin. He disclosed that Alhaji Yahaya promised to give him N1.5 million, a good car, and a house at which he agreed to provide the part in one week. Daily Independent learnt the Alhaji had fled to Abuja while Ataka who took him to the Alhaji is also said to be on the run as at time of filling this report. However, *Daily Independent's* Correspondent put a call across to the Police Public Relation Officer, Mallam Aminu Lawal, who stated that he was not aware of the incident but would make enquiries to confirm.
