AKURE – Commissioner of Police Undie Adie of Ondo State Police Command on Thursday at state Command Headquarters, Akure, the state capital, paraded fifteen persons arrested for different criminal activities.

Parading the suspects, spokesman to the Command, Assistant Superintendent of Police Tee-Leo Ikoro, who addressed newsmen on behalf of the Commissioner, disclosed that on December 21, 2019 at 3:00am, a four-man gang of armed robbers allegedly invaded the Orogun Adebayo's home at Iron in Ose Local Government Area of Ondo State and in the process shot dead the husband, Mr. Orogun Adebayo.

Having killed the man, the bandits robbed the family of valuables including the sum of twenty five thousand naira, one Samsung Galaxy phone, one Tecno 4 phone, one Tecno 6 phone, one Infinix phone, two ITEL phones and unspecified amount of money from the deceased's car.

The Police Commissioner revealed that the wife of the victim, Mrs. Adejoke Orogun, reported the incident at Ifon Police Station.

The case was later transferred to Special Anti-Robbery Squad for investigation.

Detectives swung into action and Lucky Ofanyi(36), living at New Town, Oke-Aro, Akure, Daniel Okhio(40) also resident in New Town, Oke- Aro, Akure, Godwin Friday Billy(32) living in Market Street, Iron and Femi Adesanya(45) resident in Oke Ogun, Owo were arrested in connection with the crime.

Godwin Friday claimed that he was not part of the band, claiming that the other three suspects only asked him if he knew the way to the deceased's residence.

According to him, "I am not part of their gang. They only asked me if I know the man and his house.


I described the house to them and that’s all.”

When asked if he was compensated for describing the place to the gang, he sworn that he was not offered anything.

Godwin, who was sobbing all through the parade, said: “I didn’t ask them for anything after describing the man’s house to them. They didn’t give me anything.


“I didn’t know that they were asking for the man’s house with the intention of robbing him.

“They gave me the impression that they were given appointment by the man. That was why I described the place to them. I didn’t know they wanted to go and rob him.

“So, I didn’t know anything about their plan and I am not one of them.”

Displayed before the suspects are items the Police said they recovered from them.

They include one pump action riffle loaded with seven rounds of live ammunition, one locally made double barrel pistol loaded with two live cartridges, one cutlass, one Iron Bar, one Infinix phone and one Tecno phone belonging to the deceased and his wife.

The Police Commissioner said all the suspects confessed to have taken part in the robbery operation.

He, therefore, assured that all suspects would be arraigned in court as soon as investigations are concluded.
