Proper Ways To Handle, Transport Accident Victims

he Yuletide season is over, but activities marking the aftermath are also as pulsating as the season, owing to the frenzied approach to work and businesses after the long holidays.

A number of people approach the unfolding New Year with the aim to quickly recover the dip in their finances, brought about by expenses made in the course of the Christmas celebrations.

This period is also noted for its high number of travelers who are wont to return to base after the celebrations from the places traveled to, resulting in higher traffic of passengers and vehicles jos-

liting for the right of way on the roads.
Once again, we find drivers, especially commercial drivers who are desperate to maximise profit by making return trips over and above what is obtainable in normal circumstances.

News monitored by DAILY INDEPENDENT, shows that about 48 road crashes were reported to have occurred across the country in the first three weeks of January alone, with over 350 lives lost in the various incidents. Majority of these crashes are attributed to desperation and gross indiscipline exhibited by drivers, or what is commonly

referred to as human factors.

Many of the deaths are as a result of the poor handling of the victims of these crashes by first responders who often are bereft of what to do, resulting in the manhandling of the victims, leading to seizures, compli-

cations, and cutting of breaths.

Many victims would have survived the accidents, but out of poor management of

their case they gave up the ghost.

Another sad narrative of first responders to accident victims in Nigeria are those who come to the scene of victims writhing in pain only for them to bring out their phones to take pictures of the victims to post online.

It is also reported of some first responders who are quick to ransack the pockets, bags, and possession of the victims to steal their valuables; afterwards they will disappear from the scene leaving the poor victims to their fate.

The worse are the hospitals or clinics where such victims are rushed to, who reject them on the flimsy reason that the first responders need to obtain a police report before they can attend to the accident victims.

Some first responders are subjected to some of the most debilitating embarrassments by police authorities for their good acts, discouraging many who may want to


offer such help in the future.

Ajibade Adekunle, Area Commander,
TRACE, Ado Odo Ota, Ogun state, said: "Many first responders to accidents victims lack basic training to know what to do in the case of a road crash, and this could prove fatal if the wrong approach is given to them.

That is the reason why the public are asked to call the emergency line; in the country we use 112, which are linked to rescue agencies like ours for prompt response to such incidents. It is good for help to get to accident vic-tims on time, but what would a hurried help be, if it worsens an already bad situation?

"Our men have been thoroughly trained for such unforeseen circumstances and I would like the motoring public to always contact our Corp in such case, especially if such crash is within our jurisdiction, in Ogun state. I also believe as a responsive government, efforts are been made to provide more ambulance points

on our highways," he added.
The passion to see an improvement in the way accident victims are treated by first responders Expecially those COVID-19 infected patients, led GreenLight Initiative Group, in partnership with the Ministry of Health, Lagos State and the Federal Road Safety Corps, FRSC, to carry out a COVID-19 response safety training in La-80s which is aimed at empowering ambulance and truck drivers on the safe handling of crash

According to Simon Patrick Obi, Executive Director, GreenLight Initiative, he said: "The training modules are designed to empower these drivers and assistants with COVID-19 safety protocols; basic infection prevention control; basic first aid, appropriate and rational use of personal protective equipment (PPE) and education or mad safety measures.
"The training will enable these drivers to

protect themselves from contracting COVID-19, enforce and advocate for COVID-19 safety proto-cols as they deliver on their jobs; and ensure that COVID-19 supplies and equipment are delivered to hospitals in a safe and timely manner", he said. Dr Ena Oshinowo, Senior Manager, Trau-

ma Care International Foundation (TCTF), an NGO, while speaking recently at training for first responders, said the Foundation had collaborated with FRSC to train 100 first sponders during the ember months.

Oshinowo said that the foundation's car

paign, tagged "Operation Mobile Human Ambulance" was aimed at providing basic Cardio pulmonary Resuscitation (CPR) and First Aid skills to vulcanizers, commercial drivers, filling station attendants and critical bystanders on maor highways and accidents prone routes.

She said that the scheme also targeted at up-skilling personnel of FRSC as well as Special Marshals on CPR, First Aid and crowd control

Oshinowo said that Trauma Care International and Health Emergency Initiative (HEI) had trained 159 first responders and other critical stakeholders on CPR, first aid and crowd control.

"First responders do not need to wait for doctors like myself before they can save lives, in case of someone in an accident who loses blood and stop breathing.

Someone who stops breathing could be revived through Cardiopulmonary Resuscitation with the support of first responders who can jumpstart the heart to bring the person back to live."Oshinowo said.

Bauchi road accident claims 21 lives of 22 passengers — January 13 Mr Yusuf Abdullahi, the Bauchi state Sector

Commander of the Federal Road Safety Corps (FRSC), has said that 21 out of the 22 passengers involved in a road accident in Bauchi have died.
