Confusion reigned at the Inter-Bau Ring-road, Asaba, in the early hours of Wednesday, after a man who was identified as a lawyer was found dead in a car, with another man believed to be a passenger.

When this reporter visited the hospital to ascertain the state of things, he was informed that “their relations have taken them away, as they have been confirmed dead”.

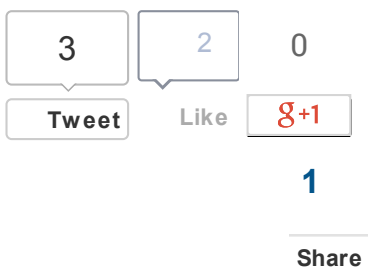
