It is apparent from the tone of the two publications that hired writers have joined the league of those who were strongly opposed to the appointment of the Chief of Air Staff.

The conscripted hired writers assigned to run-down the hard-earned reputation of the Chief of Air Staff failed woefully in their assignment and therefore, the state of emergency imposed in Adamawa State was extended for another six months.

To the greatest disappointment of the writers and their sponsors the tenure of the Chief of Air Staff was also extended to 2015 by President Goodluck Ebele Jonathan. We are not surprised by the desperation of the sponsors of the attack because of the tremendous achievements recorded Air Marshal Alex Sabundu Badeh since his assumption of office as Chief of Air Staff.

Ordinarily the publications could have been ignored, however, in view of the respect and credibility that the Leadership Newspaper commands and in the interest of unsuspecting members of the public who may accord them credibility, it is imperative to react to the misguided and selfish publications.

It is really very sad and regrettable for a sane person or group of persons to sit in the comfort of their homes to issue such publications not minding the greatest threat to lives and property as was being experienced in Adamawa State before the State of Emergency.

#### JUSTIFICATION OF THE STATE OF EMERGENCY IN ADAMAWA STATE

FRANZ FANON Once said "sometimes people hold a core belief that is very strong. When they are presented with evidence that goes against that belief, the new evidence will not be accepted. It would create a feeling that is extremely uncomfortable, called cognitive dissonance. And because it is so important to protect the core belief, they will rationalize, ignore and even deny anything that doesn't fit in with the core belief".

Therefore, as patriotic and peace-loving citizens of Adamawa State, we consider this challenge an onerous task to unveil the naked truth to all Nigerians and foreigners alike without any reservation in respect of the circumstances which created the State of Emergency in Adamawa State. We are not ignorant of the fact that in spite of the merciless and brutal killings which occurred in towns and villages before the State of Emergency those who are sponsors of this wicked act do not see any justification because they are happy and safe in their comfort zones.

The political adviser to President Goodluck Ebele Jonathan, Barrister Ahmed Ali Gulak in a Radio programme on GOTEL RADIO YOLA "Demokradiya a yau" on 1st January, 2014 said the declaration of the State of Emergency was inevitable if peace is to reign in the State. In the light of above and with all sincerity and deep sense of humility we wish to commend the Chief of Air Staff, Air Marshal, ALEX SABUNDUH BADEH and President GOODLUCK EBELE JONATHAN and other patriotic sons and daughters of Adamawa state who came to our aid during our trying period by declaring a state of emergency.

It is a fact that Adamawa state was engulfed by series of senseless killings believed to be the handiwork of BOKO HARAM insurgents from the neighbouring Borno state. Below are the recorded attacks that necessitated the declaration of the state of emergency.

- 1. GOMBI TOWN ATTACK: The first suspected BOKO HARAM attack took place in Gombi town, Headquarters of Gombi Local Government Area. The attack claimed the lives of 7 policemen, 5 UBA staff, 1 soldier from Biu Army Barracks and the destruction of properties worth millions of naira.
- 2. MUBI TOWN ATTACK: Mubi town the commercial nerve center of Adamawa state came under attack leaving in its wake 10 lgbo traders killed, 18 students of Federal Polytechnic Mubi slaughtered like rams, many people seriously injured during the stampede and property worth millions of naira perished.
- 3. ATTACK ON MAYO-NGULI: Mayo-Nguli town the headquarters of Maiha local government was also attacked by suspected BOKO HARAM insurgents. The attack claimed the lives of 15 prison inmates, 1 government official was killed at the presidential lodge, Nigerian Immigration service office, the Prison yard, Education department were all set ablaze and property worth millions of naira were destroyed.
- 4. HONG TOWN ATTACK: Hong town also experienced an attack by the insurgents. During the attack an executive of the local government was injured, police station Hong burnt down and property destroyed.
- 5. YOLA TOWN ATTACK: Yola the Adamawa state capital also came under attack by the insurgents, 10 Christian worshippers from the Christ Apostolic Church Nassarawo were shot, regional manager of First Bank Ibrahim Chindaya killed, 1 soldier killed at Jambutu ward during a shoot-out with the insurgents, L.C.C.N Vinikilang Choir Master killed by the gunmen, Luka Memorial Shopping Plaza attacked and a friend to the manager killed.
- 6. SONG TOWN ATTACK: Song town, the headquarters of Song Local Government came under attack by the suspected members of BOKO HARAM. During the attack the local government secretariat, prison yard, the police station and the education department were burnt
- 7 MADAGALI TOWN ATTACK: Gulak town and Midlu village in Madagali Local Government area were attacked by the insurgents. 4 people were killed at the Adamawa state Deputy Governor's residence in Midlu village, the police station at Gulak and Shuwa were set ablaze, 1 policeman was killed at Shuwa police station.
- 8. KALA'A TOWN ATTACK: Kala'a is the headquarters of Kulinyi Development Area in Hong Local Government Area. Suspected BOKO HARAM insurgents attacked the police out-post killing 1 detainee, while the residence of and NDIC official based in Abuja was set ablaze.
- 9. GANYE TOWN ATTACK: On Friday 22nd March 2013 Ganye town, the headquarters of Ganye local government was attacked by suspected BOKO HARAM insurgents. The attack left in its wake the Assistant Controller of Ganye prison lost his life, Mr. Adiel Billa a former commissioner of Health was killed at his residence by the attackers, the Nigerian Immigration Service office, the Police station, education department and the old local government secretariat were destroyed and property worth millions of naira perished.

FARANG FOREST: When the series of co-ordinated attacks became frequent, the Chief of Air Staff together with some security agents in Adamawa state beamed their searchlights on the possible areas where these insurgents hide to carry out the attacks, some good Samaritans disclosed some confidential information of the likely places among which was the Farang forest in Fufore local government area.

A search on Farang forest was conducted and the revelation was unprecedented. The security agents uncovered huge arms and ammunition and an unspecified number of Toyota Hilux Vans belonging to the Adamawa state government. Further investigation revealed that the Hilux Vans were never reported to the police as missing or stolen or captured at gunpoint by the BOKO HARAM insurgents. We smell a very big rat! Could the writers and sponsors of those articles against the Chief of Air Staff and the imposition of the state of emergency have anything to do with the attacks? We do not know but time will surely tell. The discovery led to a fight between the security and the insurgents in which many of the vehicles were destroyed.

It is on record that some government officials in Adamawa state are on the watch list of security agencies based on the confession of some arrested terrorists in connection with the attacks in the state.

Based on the evidence above it is therefore uncharitable, misleading and shear mischief to claim that Adamawa state should not be placed under the state of emergency because the attackers are criminals and not terrorists. The believers of this school of thought should be referred to the psychiatric ward of the Yola Specialist Hospital for immediate medication. Such mentally deranged minds would never obtain God's mercy because of the devilish nature of their thinking and action.

#### WHY THE ATTACK ON THE CHIEF OF AIR STAFF?

ESTABLISHMENT OF AIR FORCE COMPREHENSIVE SECONDARY SCHOOL YOLA: The establishment of the Air Force Comprehensive Secondary School Yola didn't go down well with those who opposed the appointment because such a feat achieved within a short period of time was unprecedented in the history of the state. There were some service chiefs from the state who could not influence even a Naval Nursery School in Yola for the benefit of the people of Adamawa state.

Understandably, such groups of people of course would never be happy because what Air Marshall Badeh did is an indictment on their ignoble stewardship. The second disgruntled group are those who wanted the Chief of Air Staff to consult them for the award of contracts so that they could collect mobilization fee and disappear thereby becoming an abandoned project in the future.

The completion of the air Force Comprehensive Secondary School Yola within the shortest possible time has brought fame, honour and popularity to the Chief of Air Staff and indicated those who were in such privileged positions but could do same
